2018 Oklahoma City Home and Garden Show

The Central Oklahoma Storm Water Alliance (COSWA) will host a booth at the Oklahoma City Home and Garden Show, January 19th - 21st at State Fair Park in Oklahoma City. The booth will feature rain barrels made from repurposed Food Quality High Density Polyethylene (HDPE) Barrels and instructions on self-installation at home.

Visit the COSWA booth #2519 to receive information about different methods of low impact development you can practice at home. These methods help reduce the amount of pesticides, fertilizers, and other chemicals that may runoff from your property and pollute local waterways.

COSWA will conduct a 'How-To' on rain barrel installation on Friday, January 19th at 1pm and Saturday, January 20th at 4pm on the 'Lifestyle Stage' at the Home and Garden Show.

- Wash your car
- Rinse tools or muddy boots
- Wash house windows

2018 Household Hazardous Waste Special Collection

The Annual Household Hazardous Waste Special Collection is scheduled for Saturday, April 7, 2018 from 9:00 a.m. to 1:00 p.m. This collection will take place on the south side of the State Fairgrounds, 3001 General Pershing Boulevard, Oklahoma City. Residents will have an opportunity to deliver unwanted computers, tires, ammunition, and prescription medication. During our last collection in Summer 2017, Oklahoma City residents dropped off over 115,000 pounds of materials! These materials should never go into our communities regular trash. Join the effort to keep these items out of the landfill.
