

PLUMBING PERMIT FEES

Article I. - In General

Article II. - Administration and Enforcement

§ 60-42-6. - Residential new construction (one- and two-family dwellings and condominiums).

- (a) all fixtures integral to the structure, base fee\$ 83.00
each bathroom, more than one or part thereof28.50
- (b) water and sewer service, each15.00
- (c) extension of more than ten feet of sanitary or storm sewer, soil pipe or water line, each extended line15.00
- (d) reinspection/trip fee42.00

§ 60-42-7. - Residential, addition or replacement (one- and two-family dwellings and condominiums).

- (a) Alteration base fee, required when alteration or addition is sufficient to require a building permit\$ 28.50
- (b) each appliance or fixture requiring connection to water and a sanitary sewer or storm sewer7.00
- (c) water or sewer connection, each25.50
- (d) extension of sanitary or storm sewer, soil pipe or water line, each extended line15.00
- (e) reinspection/trip fee42.00

§ 60-42-9. - Commercial new construction, addition, or replacement (all structures except one- and two-family dwellings and condominiums).

- (a) Alteration base fee, required when alteration or addition is sufficient to require a building permit\$ 28.50
- (b) fixture or appliance or connection not specified, § 42-10, each7.00
Each appliance or fixture connecting to water and/or storm or sanitary sewer must be listed on permit.
- (c) add or replace water or sanitary sewer service, each25.50
- (d) extension of sanitary or storm sewer, soil pipe or water line, each extended line14.50
- (e) reinspection/trip fee42.00

§ 60-42-10. - Special plumbing fees.

- (a) commercial dishwasher, each\$ 15.00
- (b) garage grit or grease interceptor, each15.00
- (c) commercial garbage disposal15.00

- (d) commercial washing machine:
 - one machine15.00
 - two to seven machines, same location25.50
 - seven to 15 machines, same location116.00
- (e) carwash (automatic)28.50
- (f) slaughterhouse special traps, each28.50
- (g) alteration, moving building28.50
- (h) yard sprinkler system28.50
- (i) fire protection yard line58.50
- (j) reinspection/trip fee42.00

§ 60-42-11. - Oklahoma Uniform Building Code Commission collection fee.

In addition to any fee prescribed by this title, each permit issued for plumbing construction shall also pay an administrative fee for the collection and remittance of fees to the Oklahoma Uniform Building Code Commission as established by 59 O.S. § 1000.25,

Administrative Collection Fee, per permit\$0.50

§ 60-42-16. - Plumbers' registration fees.

- (a) journeyman, registration of State license with City\$ 50.00
 - registration renewal, annual28.00
 - renewal after expiration of 90-day grace period50.00
- (b) contractor, master plumber (bond required):
 - registration of State license with City100.00
 - registration renewal, annual30.00
 - renewal after expiration of 90-day grace period100.00
