**LEGAL DESCRIPTION:** All of Lot One (1), In Block Seven (7), In ROBERTS LAKEVIEW ADDITION in Oklahoma County, Oklahoma, as shown by the recorded plat thereof, EXCEPT a part of Lot One (1) being more particularly described as follows: BEING East of a line extending In a Northeasterly direction from a common corner formed by the Intersection of Lots 1, 2, 4 & 5, the line to extend to a point on the North side of Lot (1), 165.34 feet East of Drexel Avenue, Block Seven (7), in ROBERTS LAKEVIEW ADDITION.

**Your property is not included within the area proposed to be rezoned. This notice is being provided to you because you own property nearby.**

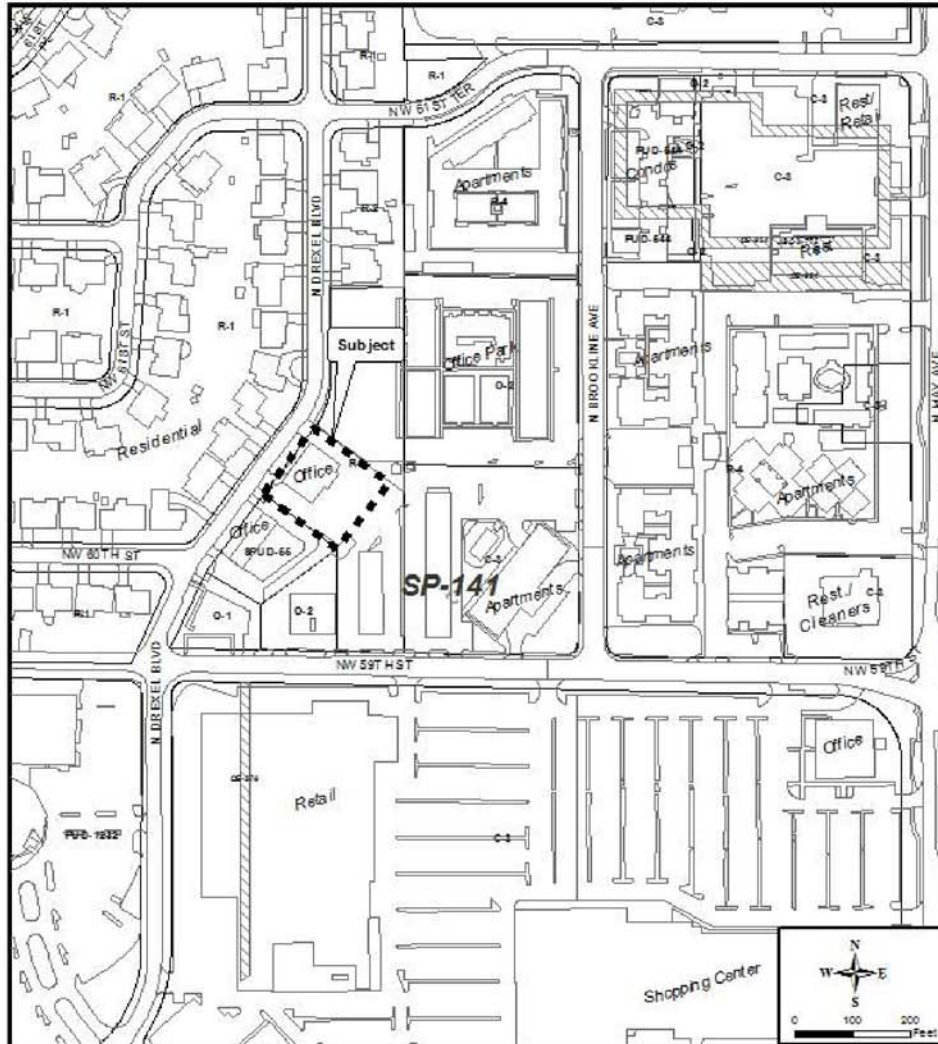

All of Lot One (1), In Block Seven (7), In ROBERTS LAKEVIEW ADDITION in Oklahoma County, Oklahoma, as shown by the recorded plat thereof, EXCEPT a part of Lot One (1) being more particularly described as follows: BEING East of a line extending In a Northeasterly direction from a common corner formed by the Intersection of Lots 1, 2, 4 & 5, the line to extend to a point on the North side of Lot (1), 165.34 feet East of Drexel Avenue, Block Seven (7), in ROBERTS LAKEVIEW ADDITION.

### **BRIEF DESCRIPTION OF PROPOSED ZONING DISTRICT:**

This site will be developed in accordance with the regulation of the modified **O-1 Limited Office District** (OKC Zoning Ordinance, 2010).

At any time not later than three days prior to said hearing, any owner of property within the district affected, or any owner of property within a 300 foot radius of the exterior boundary of the subject property, may make legal written protest by filing the same with the Office of the City Clerk, 200 North Walker Avenue, Oklahoma City, Oklahoma 73102.
