COMMENCING at the Northwest corner of said Northwest Quarter (NW/4); THENCE South 00°23'01" East, along the West line of said Northwest Quarter (NW/4), a distance of 699.99 feet to the POINT OF BEGINNING; THENCE North 89°37'00" East, along a road right of way recorded in Book 7408, Page 1606, a distance of 80.00 feet; THENCE North 00°23'01" West, parallel to the West line of said Northwest Quarter (NW/4) and along said right of way, a distance of 199.25 feet; THENCE South 89°51'05" East, parallel with the North line of said Northwest Quarter (NW/4), a distance of 500.00 feet; THENCE South 00°23'01" East, parallel with the West line of said Northwest Quarter (NW/4), a distance of 700.05 feet; THENCE North 89°51'08" West a distance of 178.69 feet; THENCE North 70°39'57" West a distance of 150.84 feet; THENCE South 89°19'40" West a distance of 259.30 feet to a point on the West line of said Northwest Quarter (NW/4); THENCE North 00°23'01" West, along the West line of said Northwest Quarter (NW/4), a distance of 454.20 feet to the POINT OF BEGINNING.

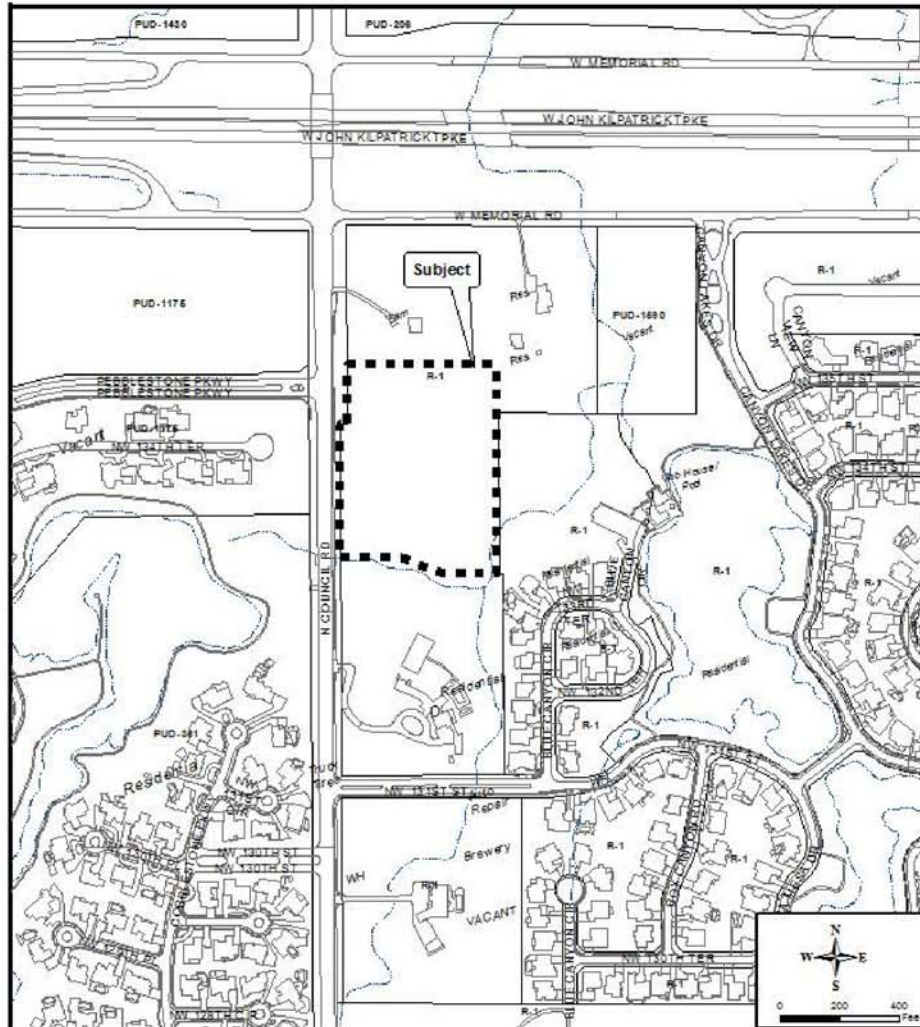
