This notice is to inform you that **Titan Lansing Transloading, LLC** filed an application with The City of Oklahoma City to change the zoning designation of the property to the PUD-1692 Planned Unit Development District. The City Council will consider this zoning application at a public hearing on September 25, 2018. The only property to be rezoned is outlined on the attached map. **The City Council meets in the Council Chambers, Third Floor, Municipal Building, 200 North Walker Avenue, Oklahoma City, Oklahoma beginning at 8:30 a.m.**

**LEGAL DESCRIPTION:** A tract of land situated within a portion of the Northwest Quarter (NW/4) of Section Twenty-Seven (27), Township Ten North (T10N), Range Four West (R4W) of the Indian Meridian (I.M.), Cleveland County, Oklahoma, being more particularly described as follows:

BEGINNING at the Northwest Corner of said NW/4; thence N90° 00' 00" E along the North line of said NW/4 a distance of 1130.97 feet; thence S46° 00' 00" W a distance of 710.89 feet; thence S90° 00' 00" W, parallel to the North line of said NW/4, a distance of 621.75 feet to a point on the West line of said NW/4; thence N00° 15' 00" E along the West line of said NW/4 a distance of 493.83 feet to the POINT OF BEGINNING.

**Your property is not included within the area proposed to be rezoned. This notice is being provided to you because you own property nearby.**

**You are not required to attend the hearing, but if you wish to you may. You can also have someone appear on your behalf.**

If you object to the rezoning of the property, you can file legal written protest no later than three days prior to the hearing, with the Office of the City Clerk, 200 North Walker Avenue, Oklahoma City, Oklahoma 73102.

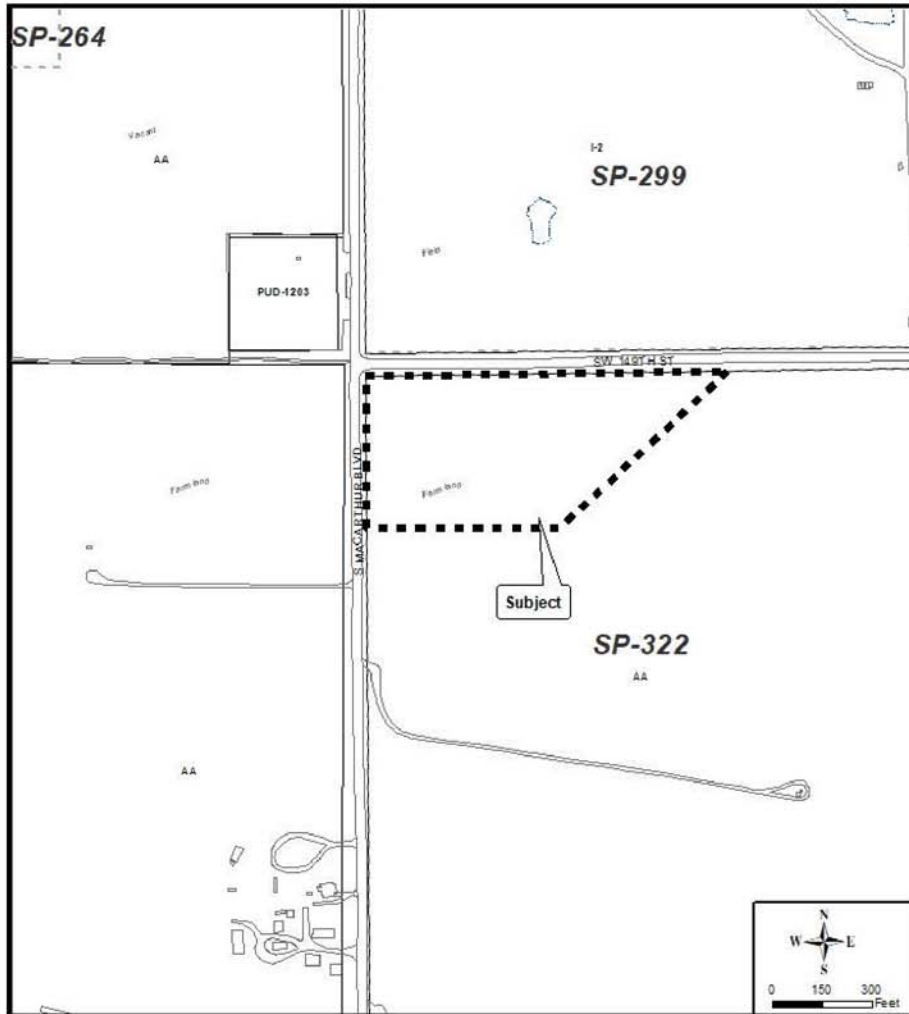

**NOTICE IS HEREBY GIVEN**, that the City Council of Oklahoma City will hold a public hearing on a proposed ordinance, extending the limits of the PUD Planned Unit Development District from the AA Agricultural District. A public hearing will be held by the City Council on September 25, 2018. **The City Council meets in the Council Chambers, Third Floor, Municipal Building, 200 North Walker Avenue, Oklahoma City, Oklahoma beginning at 8:30 a.m.**

Under the terms of said ordinance, the limits of and boundaries of the PUD Planned Unit Development District would be extended to include the following described property:

A tract of land situated within a portion of the Northwest Quarter (NW/4) of Section Twenty-Seven (27), Township Ten North (T10N), Range Four West (R4W) of the Indian Meridian (I.M.), Cleveland County, Oklahoma, being more particularly described as follows:

BEGINNING at the Northwest Corner of said NW/4; thence N90° 00' 00" E along the North line of said NW/4 a distance of 1130.97 feet; thence S46° 00' 00" W a distance of 710.89 feet; thence S90° 00' 00" W, parallel to the North line of said NW/4, a distance of 621.75 feet to a point on the West line of said NW/4; thence N00° 15' 00" E along the West line of said NW/4 a distance of 493.83 feet to the POINT OF BEGINNING.

This site will be developed in accordance with the regulation of the modified **AA Agricultural District** (OKC Zoning Ordinance, 2010).

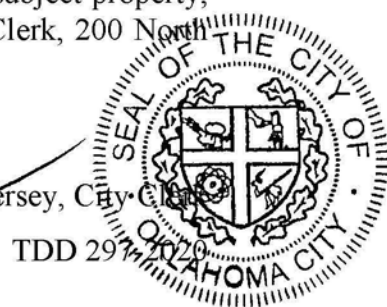
