NOTICE IS HEREBY GIVEN, that the City of Oklahoma City has a certain Capital Improvement project that requires the services of a consulting firm.

In order to be considered, the Consultant must comply with the Resolution establishing procedure for "Selection of Architects, Engineers, and Planners" adopted by the City Council on November 18, 1986, a copy of which may be obtained at <https://www.okc.gov/departments/public-works/engineer-architect-resources/notice-to-a-e> or from the office of the Public Works Department Director.

The Project is as follows: **PC-0557 – Roadway Widening – SW 15th Street from South Czech Hall Road to South Mustang Road.**

Scope of Work: Roadway Widening and Improvements for SW 15th Street from South Czech Hall Road to South Mustang Road.

This project will consist of roadway widening for the above location. Improvements will also include intersection improvements at SW 15th Street and Czech Hall Road, drainage, ADA, and sidewalk improvements and will include coordination with the construction of the new John Kilpatrick Turnpike.

Estimated Construction Cost \$3,300,000

The Project is as follows: **PC-0559 – Roadway Widening – South Sara Road from SW 15th Street to SW 29th Street.**

Scope of Work: Roadway Widening and Improvements for South Sara Road from SW 15th Street to SW 29th Street.

This project will consist of roadway widening and bridge improvements for the above location. Improvements will also include intersection improvements at SW 15th Street and South Sara Road, drainage, ADA, and sidewalk improvements and will include coordination with the construction of the new John Kilpatrick Turnpike.

Estimated Construction Cost \$4,500,000



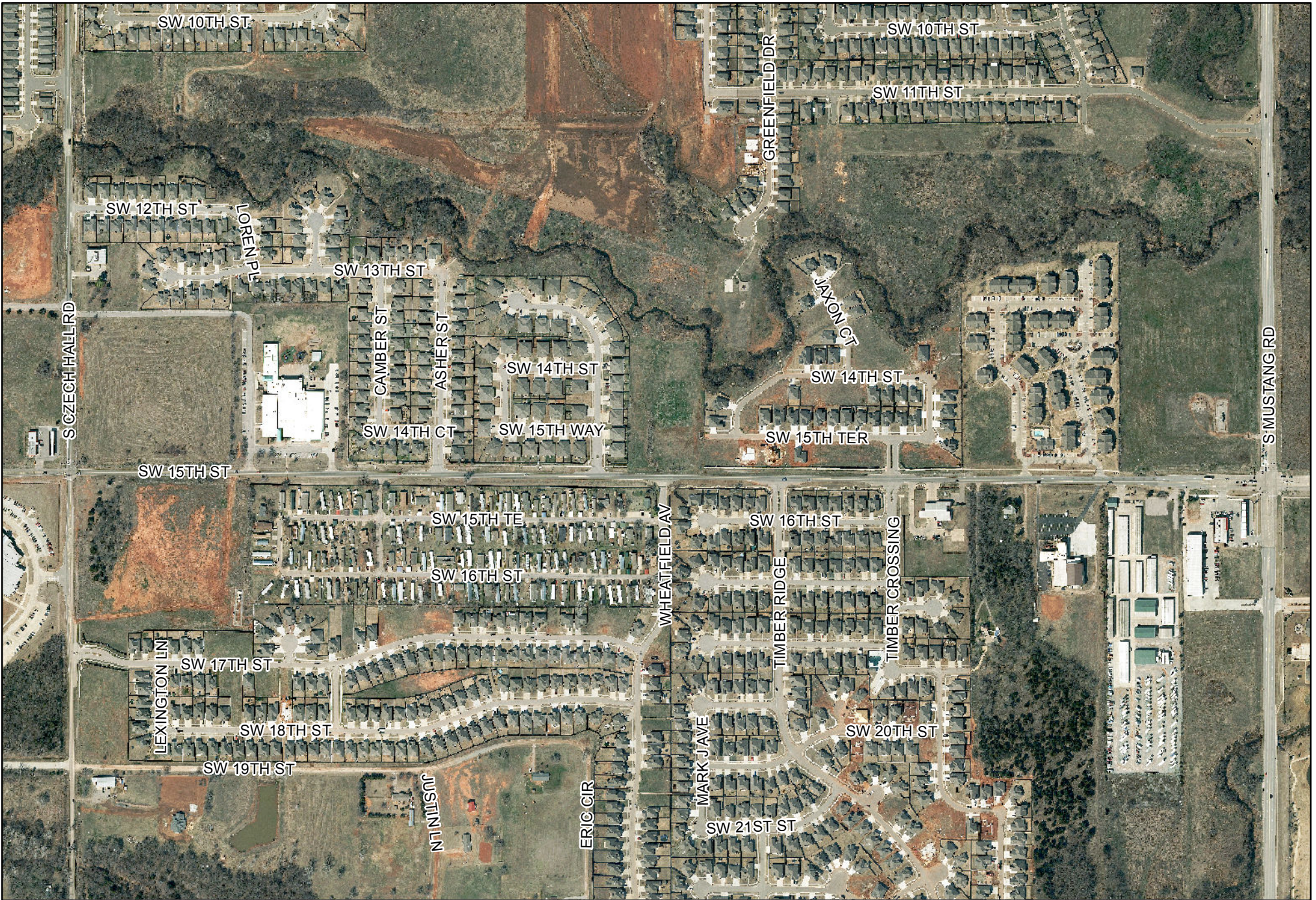

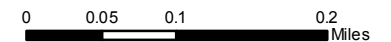
