

NOTICE TO ARCHITECTS, ENGINEERS, AND PLANNERS

NOTICE IS HEREBY GIVEN, that the City of Oklahoma City has a certain Capital Improvement project that requires the services of a consulting firm.

In order to be considered, the Consultant must comply with the Resolution establishing procedure for "Selection of Architects, Engineers, and Planners" adopted by the City Council on November 18, 1986, a copy of which may be obtained at <https://www.okc.gov/departments/public-works/engineer-architect-resources/notice-to-a-e> or from the office of the Public Works Department Director.

The Project is as follows: **PC-0611** – Streetscape – in an area bounded by NW 39th Street and NW 40th Street, Pennsylvania Avenue and Youngs Boulevard.

This project will consist of district markers, crosswalks, ramps, sidewalks, lighting and landscaping.

Estimated Construction Cost \$1,600,000

The Project is as follows: **PC-0612** – Streetscape – "The Paseo", in the vicinity of Paseo between NW 28th Street and NW 30th Street.

This project will consist of crosswalks, ramps, sidewalks, lighting, landscaping and drainage solutions with consideration for Green Infrastructure strategies.

Estimated Construction Cost \$2,700,000

The Project is as follows: **PC-0613** – Streetscape – Portland Avenue between NW 23rd Street and NW 36th Street.

This project will consist of crosswalks, ramps, sidewalks, lighting and landscaping.

Estimated Construction Cost \$2,600,000

The Project is as follows: **PC-0614** – Streetscape – "Stockyards", in the vicinity of Agnew Avenue and Youngs Boulevard from SW 8th Street to SW 15th Street and Exchange Avenue from Rockwood Avenue to Pennsylvania Avenue.

This project will consist of crosswalks, ramps, sidewalks, lighting and landscaping.


Estimated Construction Cost \$2,300,000

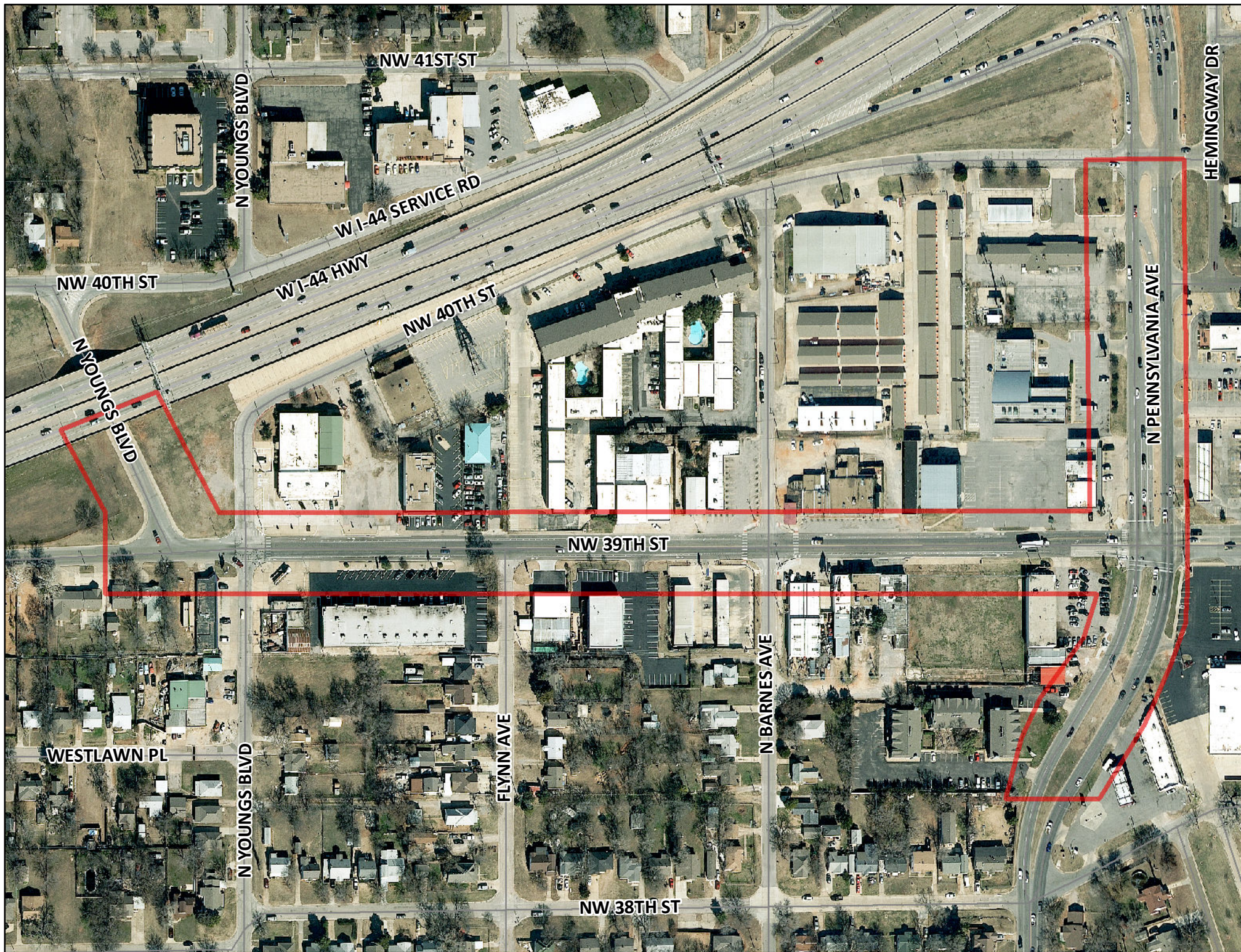

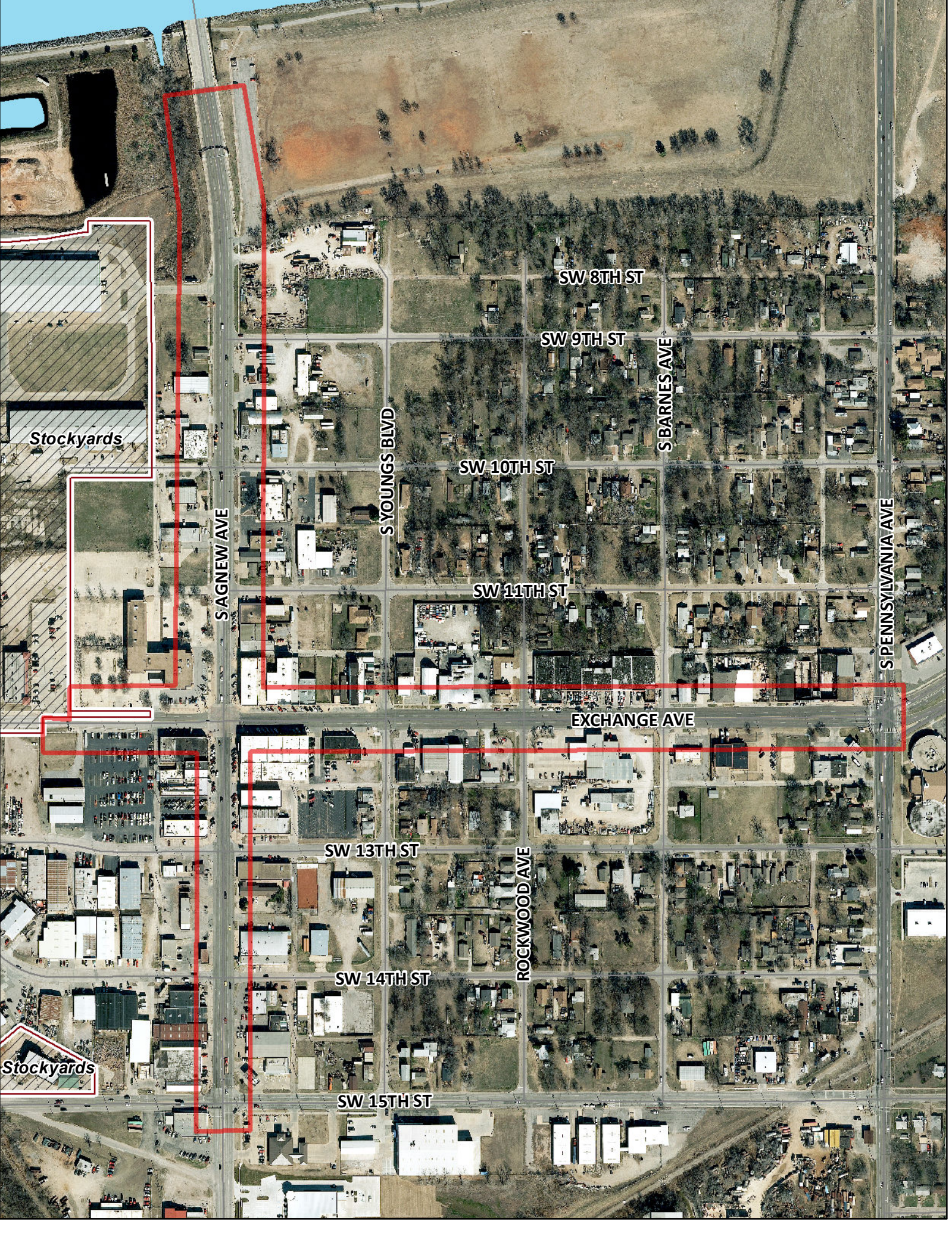
