

Estimated Project Duration: Preliminary Engineering Report (180 days) Plans and Specification (360 days)

Background: The City of Oklahoma City (City) owns and operates and the Oklahoma City Water Utilities Trust (OCWUT) leases and finances a water and wastewater system that provides services within Oklahoma City and other areas in and around the City. The Utilities Department includes several operating divisions responsible for operation and maintenance of these systems. These divisions that are operational in function include Line Maintenance, Water Quality, Wastewater Quality, Fleet Maintenance, and Utility Customer Service. To operate more efficiently and to ensure there is sufficient space for current and future staff requirements, a centralized operations center at NW 5th Street and N Pennsylvania is proposed within the current five-year capital plan with additional phases in the future as necessary. The site currently contains the Overholser Water Treatment Plant (to be decommissioned in the future), Line Maintenance, and Fleet Maintenance.

Project Intent: OCWUT proposes to have a consultant evaluate and provide a preliminary report that is a comprehensive facility plan for the Utilities Operation Center. The evaluation shall accommodate current and proposed requirements with prioritized phasing of the improvements for the Utilities Operations Center. The final report will be developed based on numerous meetings to get stakeholder input to assist with developing the best options for site layout, functionality, and phasing for the new operations center. Following completion of the preliminary report, the Consultant will provide final design, bidding, construction administration and management, inspection and as-built services for completion of the initial phase of improvements.

Proposal Instructions: The interested consulting firms will have four weeks to submit their Letter of Interest for this project. OCWUT staff will hold a question and answer session approximately one week after advertisement for this project. Once Letters of Interest have been received at the end of the four-week period, firms will be identified (short-listed) two weeks in advance of a set interview date. The identified firms will then be free to engage OCWUT staff in meetings to gain further project specific knowledge in advance of the interview session.
