Commencing at the Northwest (NW) Corner of said Northwest Quarter (NW/4); Thence N 89°59'17" E, along the North line of said Northwest Quarter (NW), a distance of 979.73 feet; Thence S 00°05'55" E, departing said North line, a distance of 73.00 feet to a point on the existing South right of way line of NE 23<sup>rd</sup> Street and on the West right of way line of Walnut Ave., said point also being the Point of Beginning;

Thence South along the East line of Block 7 of State Capitol Addition to a point at the Southeast corner of Block 7; Thence West along the South line of Block 7 and the North right of way line of NE 22<sup>nd</sup> Street to a point on the East right of way for Oklahoma State Highway I-235;

Thence North along the West line of Block 9 to a point at the Northwest corner of Block 9 and on the South right of way of NE 22<sup>nd</sup> Street; Thence East along the North line of Block 9 to a point at the Northeast corner of Block 9; Thence South along the East line of Block 9 and on the West right of way of Central Ave to a point at the Southeast corner of Block 9 and on the North right of way of NE 21<sup>st</sup> Street;

Thence East along the North right of way line of NE 21<sup>st</sup> Street to a point at the Southwest corner of Block 10 of the State Capitol Addition; Thence North along the West line of Block 10 and the East right of way of Central Ave. to a point at the Northwest corner of Block 10; Thence East along the North line of Block 10 to a point at the Northeast corner of Block 10; Thence South along the East line of Block 10 and on the West right of way of West Capitol Square to a point at the Southeast corner of Block 10;

Thence East one-hundred (100) feet to the East right of way of West Capitol Square; Thence North along the East right of way of West Capital Square twenty (20) feet to the Southwest corner of Capitol Square; Thence North along the West line of Capitol Square and the East right of way line of West Capitol Square to the Northwest corner of Capitol Square;

Thence West along the south right of way of NE 23<sup>rd</sup> Street to the Northeast corner of Block 5 and the West right of way line of West Capitol Square; Thence South along the East line of Block 5 to a point at the Southeast corner of Block 5 and on the North line of NE 22<sup>nd</sup> Street;

Thence West along the South line of Block 5 to a point at the Southwest corner of Block 5; Thence North along the West line of Block 5 and the East right of way of Central Ave to a point on the South right of way of Northeast 23<sup>rd</sup> Street;

Thence West along the South right of way of NE 23<sup>rd</sup> Street to a point on the East line of Block 6 of the State Capitol Addition and on the West right of way of Central Ave; Thence South along the East line of Block 6 to a point at the Southeast corner of Block 6 and on the North right of way of NE 22<sup>nd</sup> Street; Thence West along the South line of Block 6 to a point at the Southwest corner of Block 6 and on the East right of way of Walnut Ave; Thence North along the West line of Block 6 to a point on the South right of way of NE 23<sup>rd</sup> Street;

Thence West along the existing South right of way of NE 23<sup>rd</sup> Street to the Point of Beginning. This description has an area of 176208.28 Square Feet or 4.045 Acres more or less.
