A Tract of land in the Northeast Quarter (NE/4) of Section Eight (8), Township Twelve (12) north, Range Four (4) West of the Indian Meridian, Oklahoma County, Oklahoma, being more particularly described as follows: Commencing at the Northeast Corner of said Northeast Quarter (NE/4); Thence S 89°59'08" W a distance of 1350.04 feet; Thence S 00°09'31" E a distance of 600.00 feet; thence S 89°59'08" W a distance of 480.13 feet; thence on a curve to the right with an arc length of 78.41 feet, a radius of 50.00 feet, a chord bearing of N 45°05'11" W and a chord length of 70.62 feet; Thence N 00°09'31" W a distance of 550.13 feet; thence N 89°59'08" E a distance of 530.00 feet to the POINT OF BEGINNING. Said tract having an area of 31,7467.64 square feet, 7.288 acres, more or less.

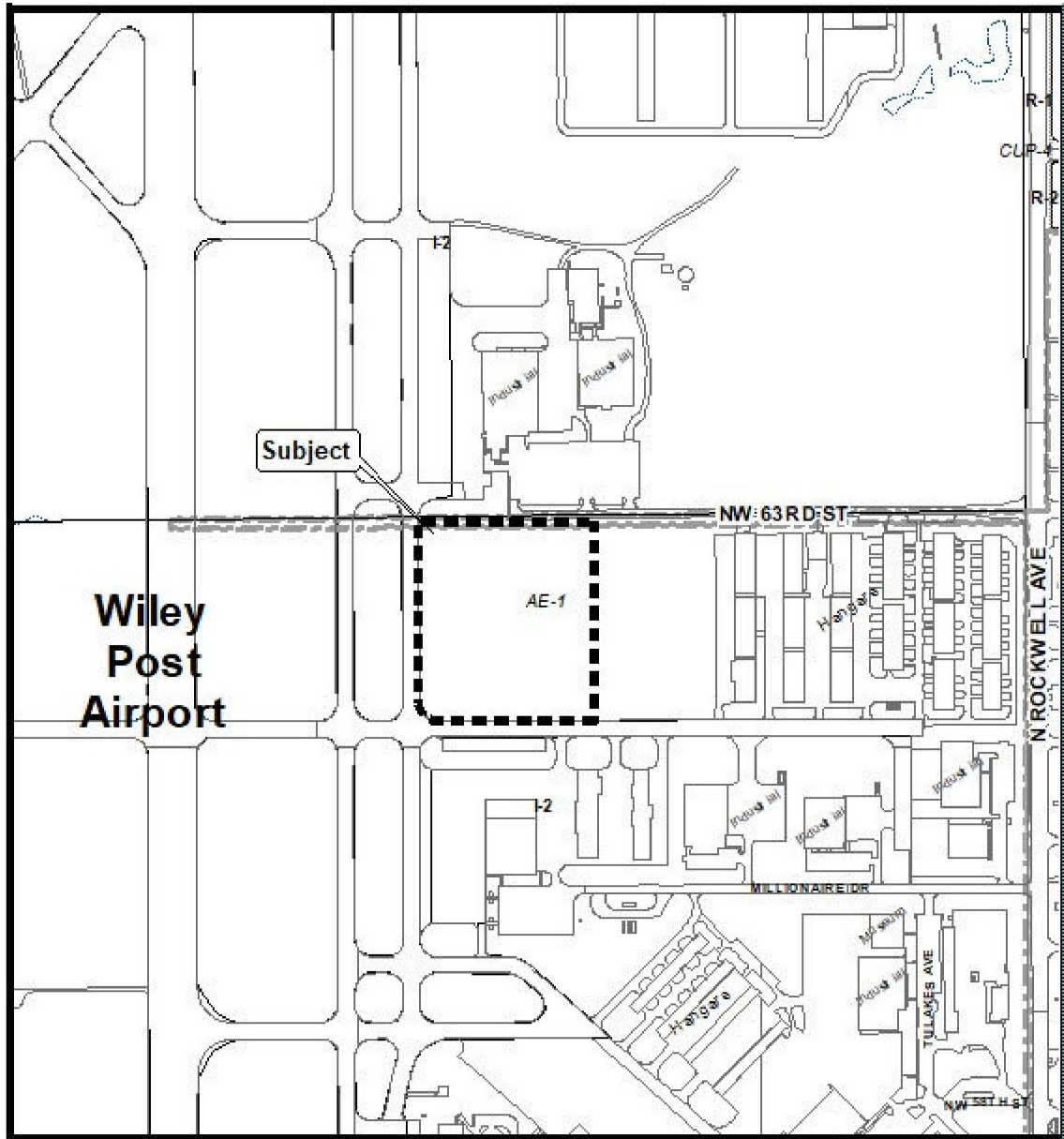


