- To speak on a certain agenda item, place a call in advance of the meeting to 405-297-2391 or text your request in advance of the meeting to 405-219-7987 or email cityclerk@okc.gov. Include your name, the agenda item number and the reason you

would like to speak (protest, representing applicant, request continuance, i.e.). Please submit your request prior to the beginning of the meeting to avoid receiving your request after your item has been considered. City staff will attempt to submit requests received during the meeting to process them to the Mayor. Please press *6 to speak when recognized by the Mayor.

The Mayor will announce at the beginning of the meeting that if connections are lost, the City will attempt to restore communications for a maximum of ____ minutes and if communications cannot be restored, the meeting will reconvene at a certain date, time and place. If you are disconnected, please try again before calling 405-297-1630 or texting 405-664-2363.

It is the policy of The City of Oklahoma City to ensure that communications with participants and members of the public with disabilities are as effective as communications with others. Anyone with a disability who requires an accommodation, a modification of policies or procedures, or an auxiliary aid or service to participate in this meeting should call (405) 297-2396 or TDD (405) 297-2020 at least 48 hours in advance (excluding weekends or holidays). The department will give primary consideration to the choice of auxiliary aid or service requested by the individual with disability before the scheduled meeting. If you need an alternative format of the agenda, or any information provided at this meeting, call (405) 297-2396 at least 48 hours before the meeting (excluding weekends or holidays).

Addressing the Council

Citizens may address the Council on any agenda item except for those agenda items falling into the exceptions identified below, but all comments must be relevant to the item. Citizens may not address the Council regarding items from "Office of the Mayor," "Items from Council" (except for items listed for a vote or if asked for comments by a Councilperson), or items under "City Manager Reports." Citizens may also address the Council on individual concerns, including on the listed exceptions, at the end of the agenda under "Citizens to be Heard." Citizens to be Heard is not provided as a forum for publicly announced or declared candidates for City public office, and they will not be allowed to speak as Citizens to be Heard. Citizens will not be allowed to campaign on any political issue during the Council meeting. Comments must concern City services or policies. Citizens who wish to be listed on the agenda for comments to Council may call the City Clerk's Office at 297-2397 before 4 p.m. on the Tuesday prior to the next Council meeting. Persons so listed on the agenda for comments to Council are subject to the same restrictions listed above. Person submitted documents to the meeting must do so three business days in advance of the meeting. Please limit your comments to three minutes.

Council Actions

Official action can only be taken on items which appear on the agenda. The Council may adopt, approve, ratify, deny, defer, recommend, strike, or continue any agenda item.

When more information is needed to act on an item, Council may refer the matter to the City Manager or the Municipal Counselor. The Council may also refer items to standing committees of the Council or to a board or commission for additional study. Under certain circumstances, items are deferred to a specific later date or stricken from the agenda entirely.
