






This chart demonstrates cases, hospitalizations, and deaths reported daily rather than cumulative based on the Oklahoma State Health Department's daily reports.

5/18 through 6/1/2020




## **COVID-19** Cases and Deaths by Race and Ethnicity








## **COVID-19 Case Status Statewide**





## Oklahoma Statewide Unemployment Claims

Claims

Unemployment claims are reported on a weekly basis every Thursday by the U.S. Department of Labor. New data published 5/28/2020:

- *Reported 33,440 initial claims filed in Oklahoma during the week ending 5/23/2020*
- *Revised upwards by 9,560 claims filed during the week ending 5/16/2020*

Each of these numbers represents the number of new unemployment claims filed in Oklahoma each week; they are **not** cumulative.

The weekly data is released, prior week data is subject to revision by the U.S. Department of Labor.

The data used here is not seasonally adjusted.
