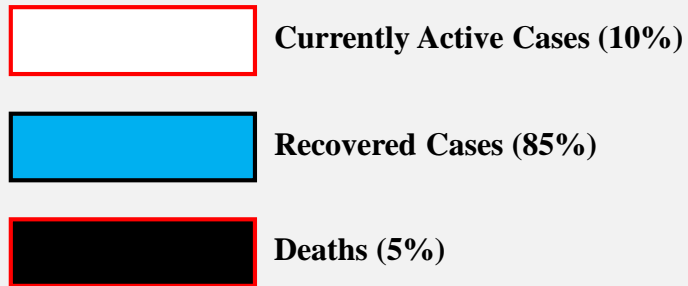
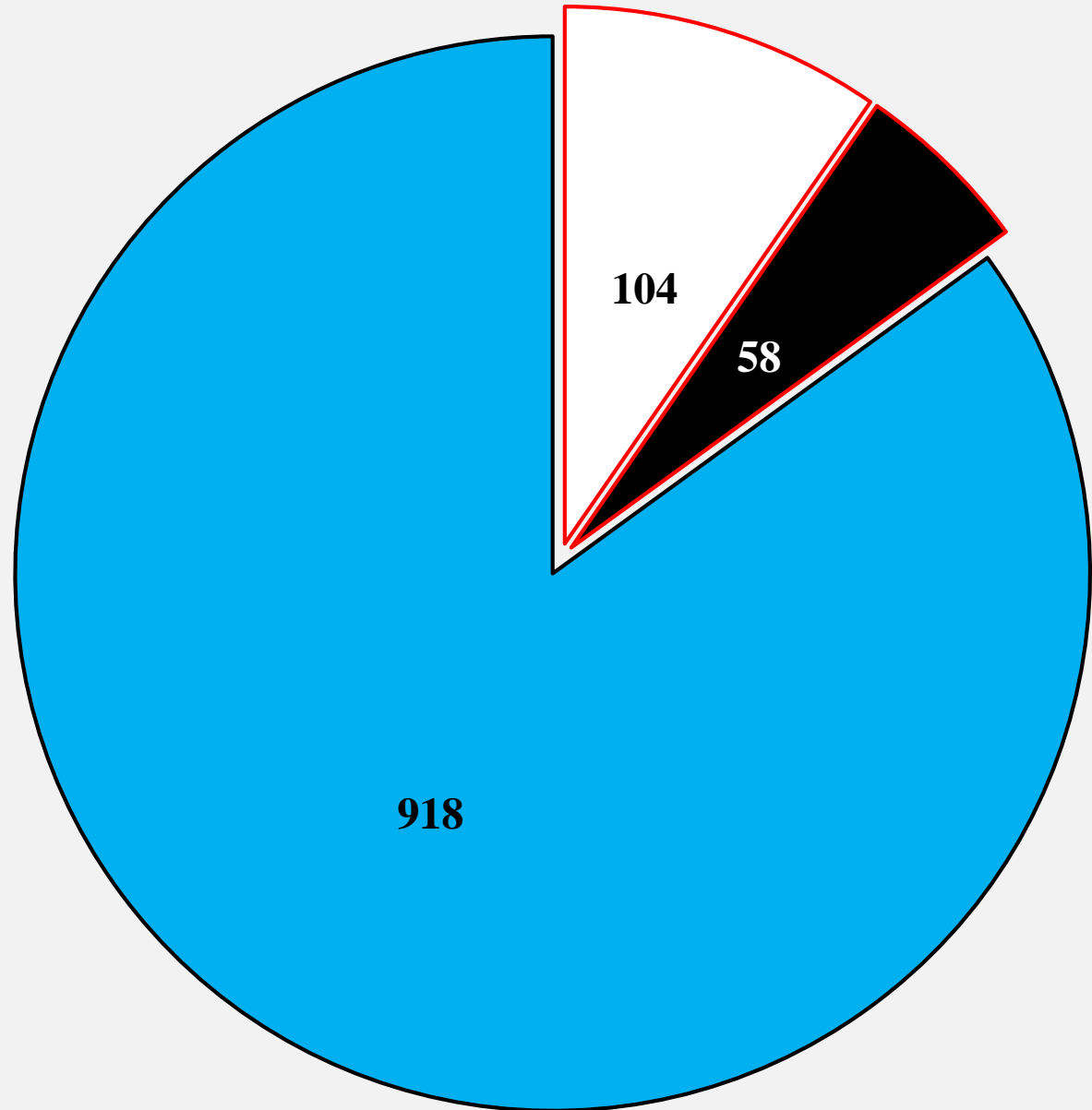

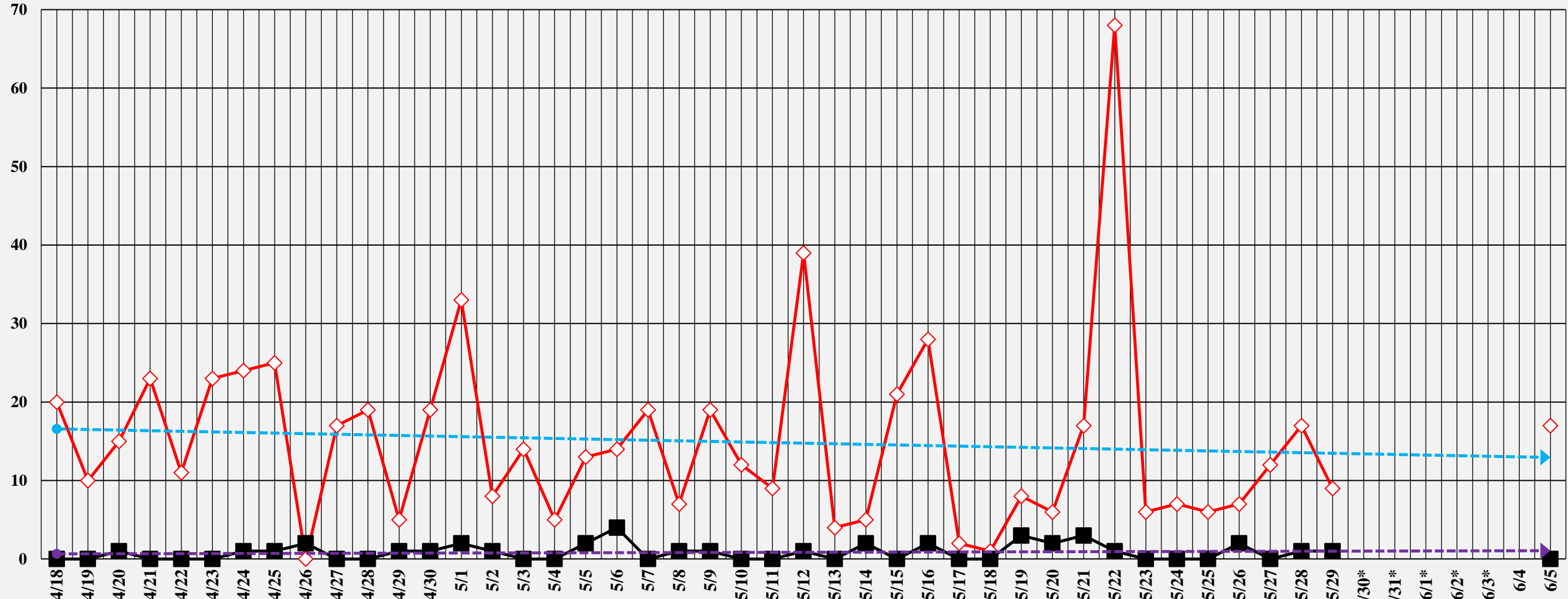


COVID-19 Oklahoma City Cases and Deaths Per Day

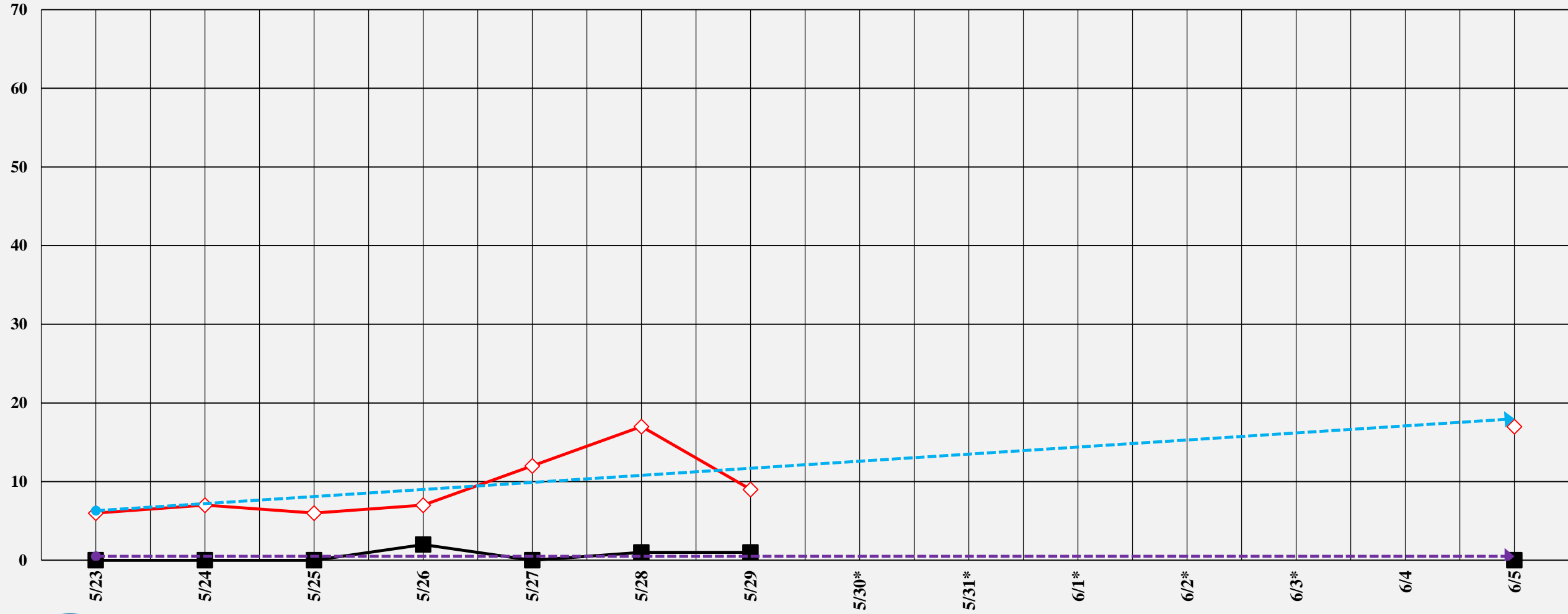

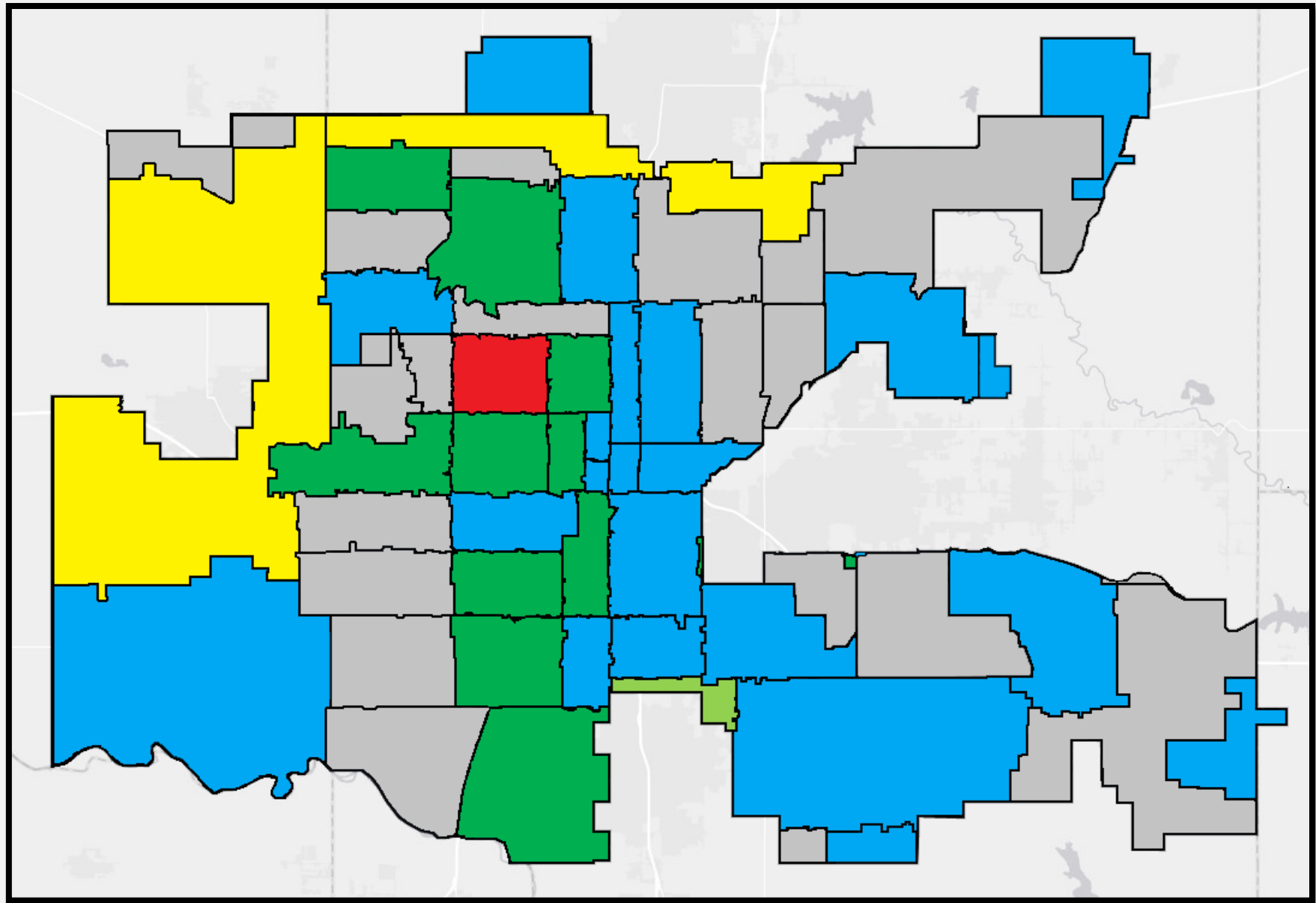
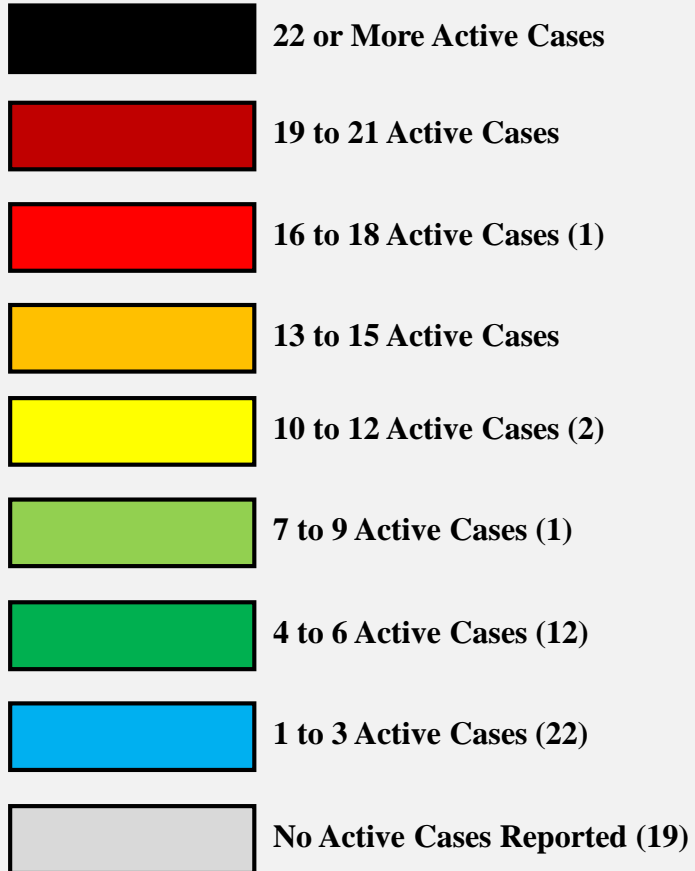

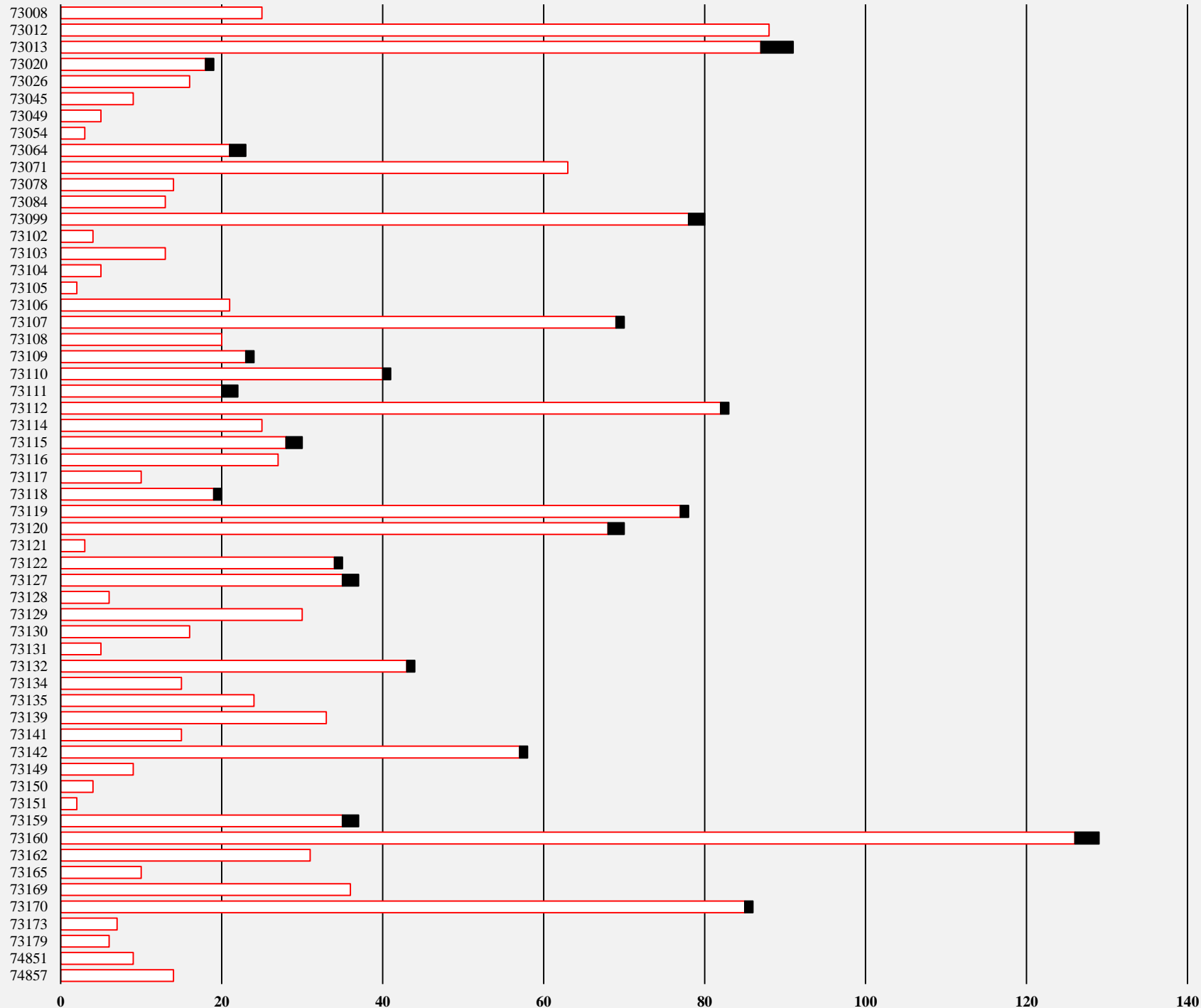

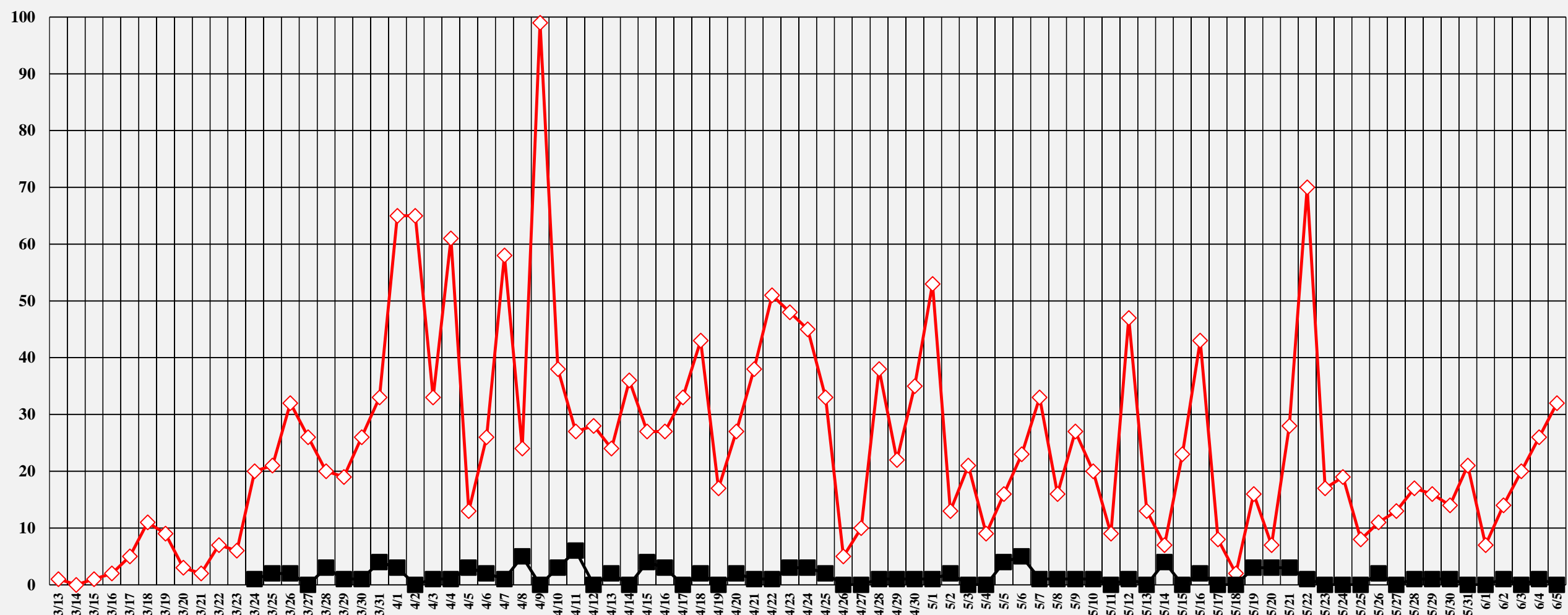

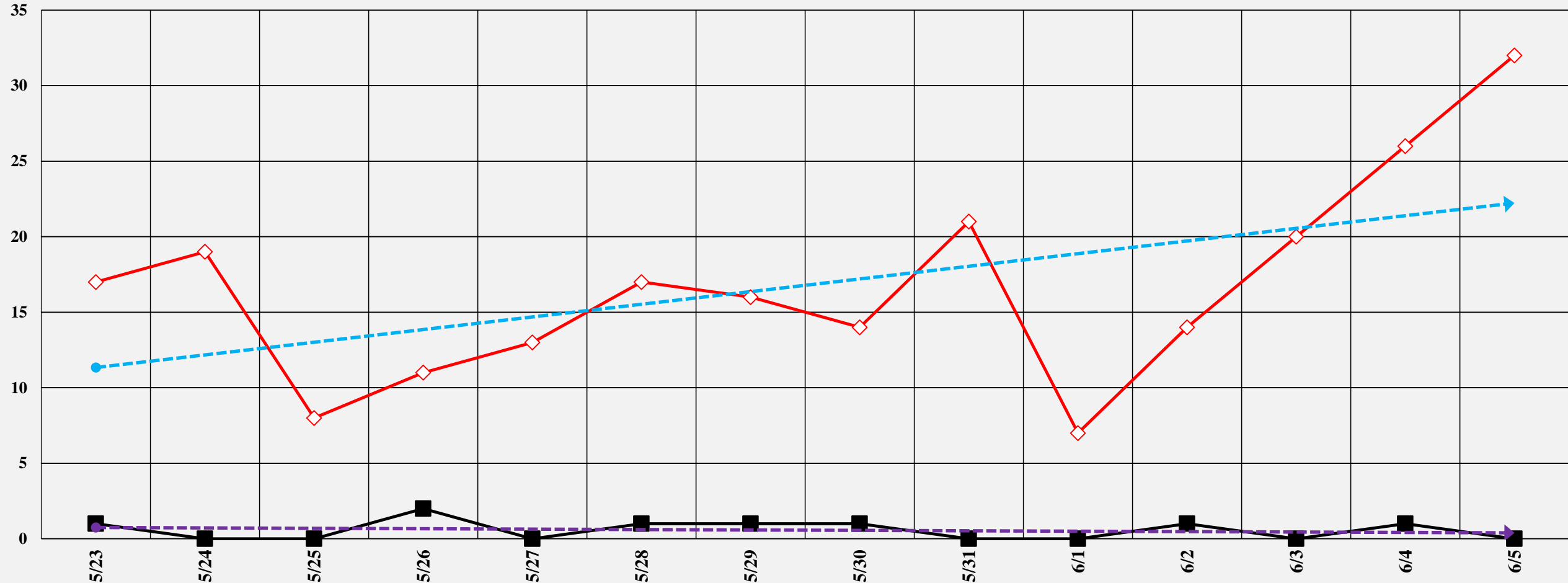

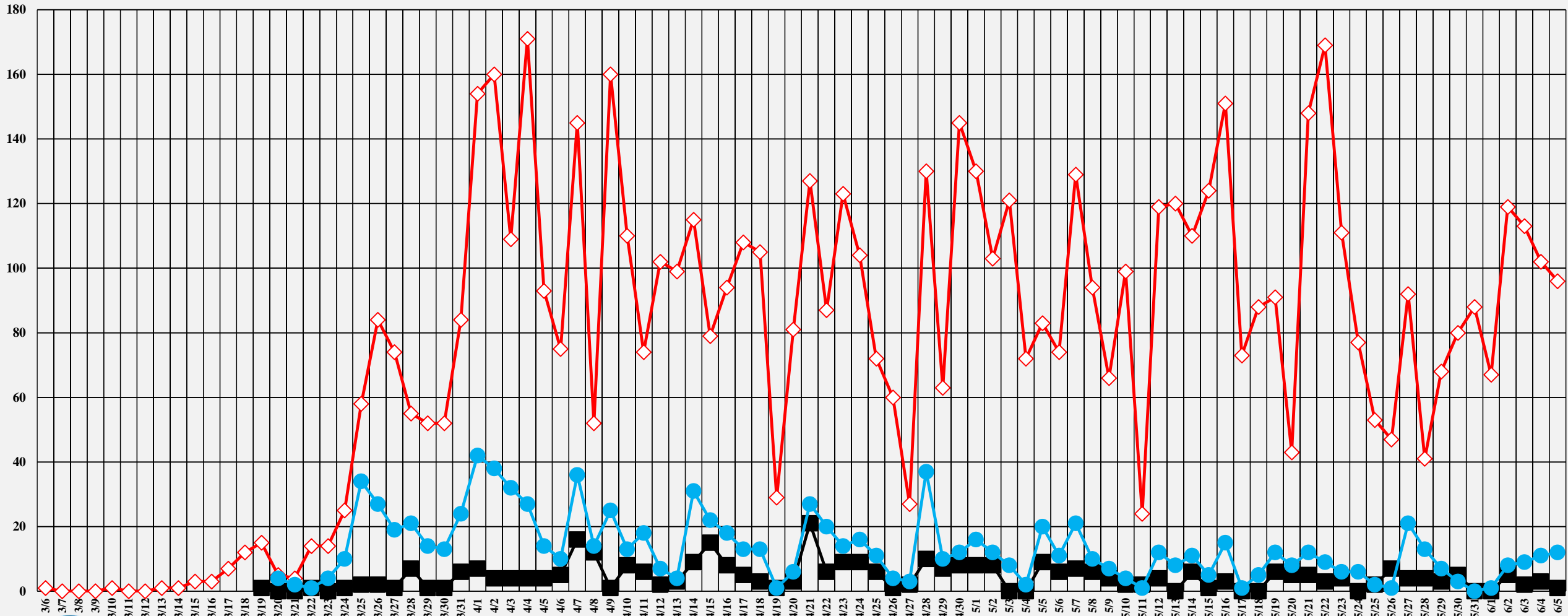
COVID-19 Statewide Cases, Hospitalizations, and Deaths Per Day

This chart demonstrates cases, hospitalizations, and deaths reported daily rather than cumulative based on the Oklahoma State Health Department's daily reports.

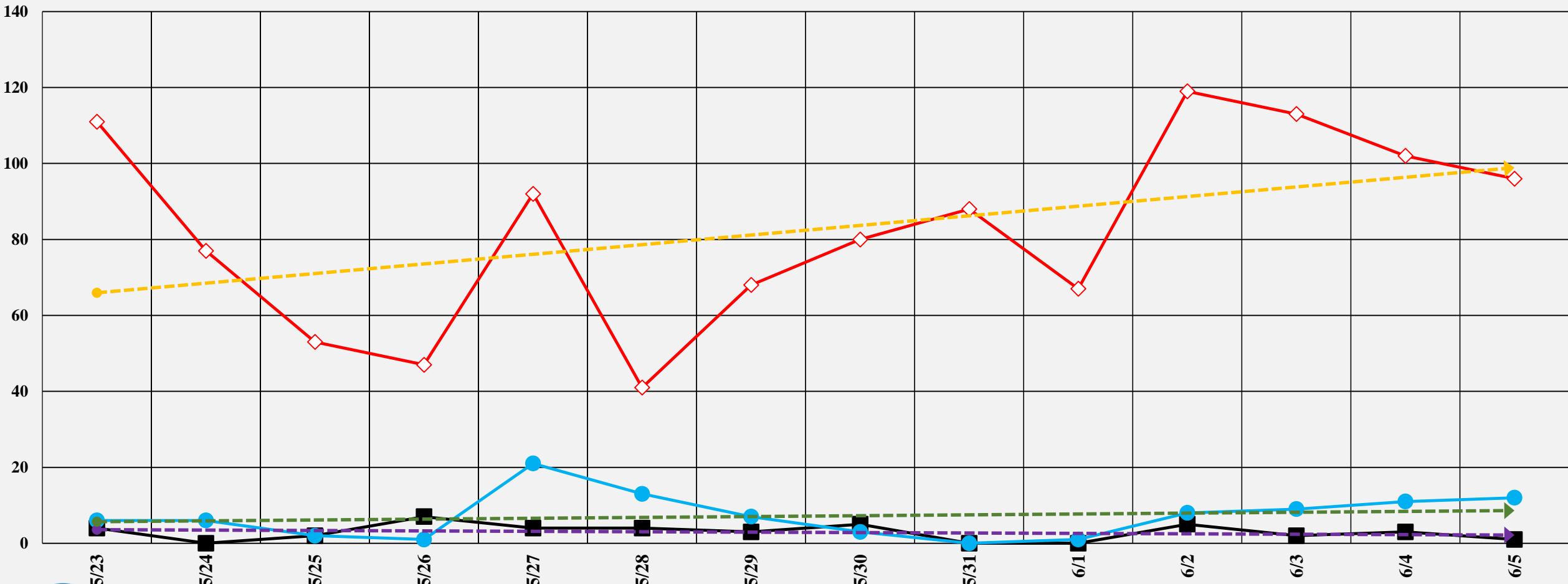
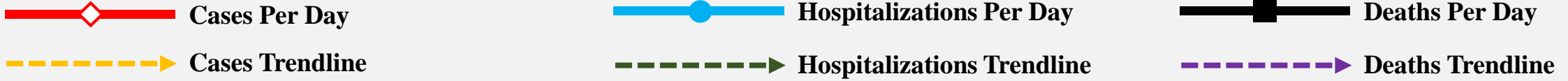

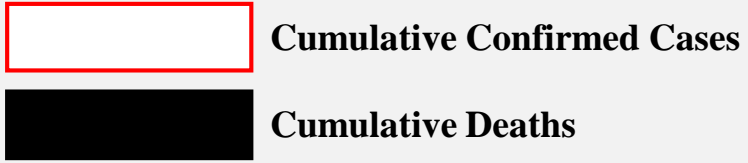

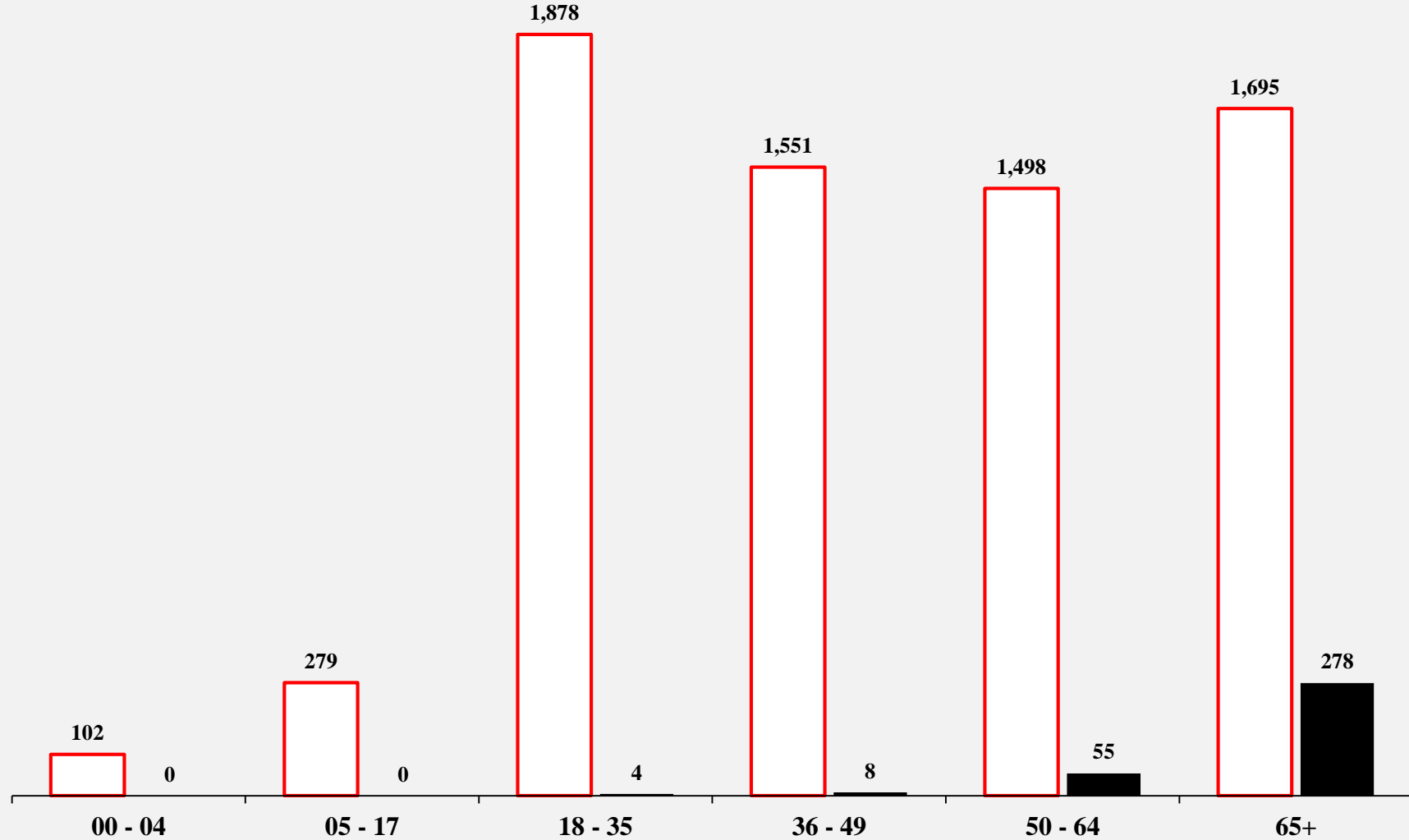

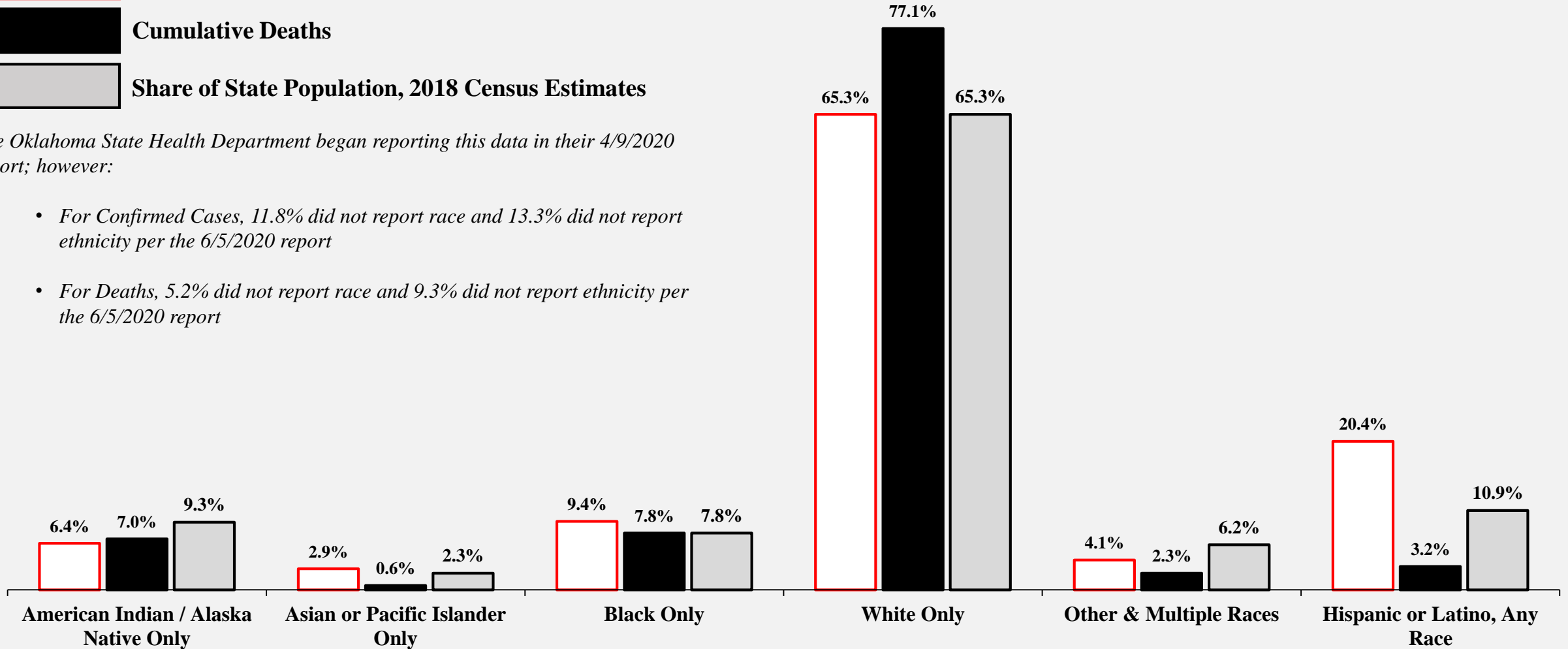

- For Deaths, 5.2% did not report race and 9.3% did not report ethnicity per the 6/5/2020 report



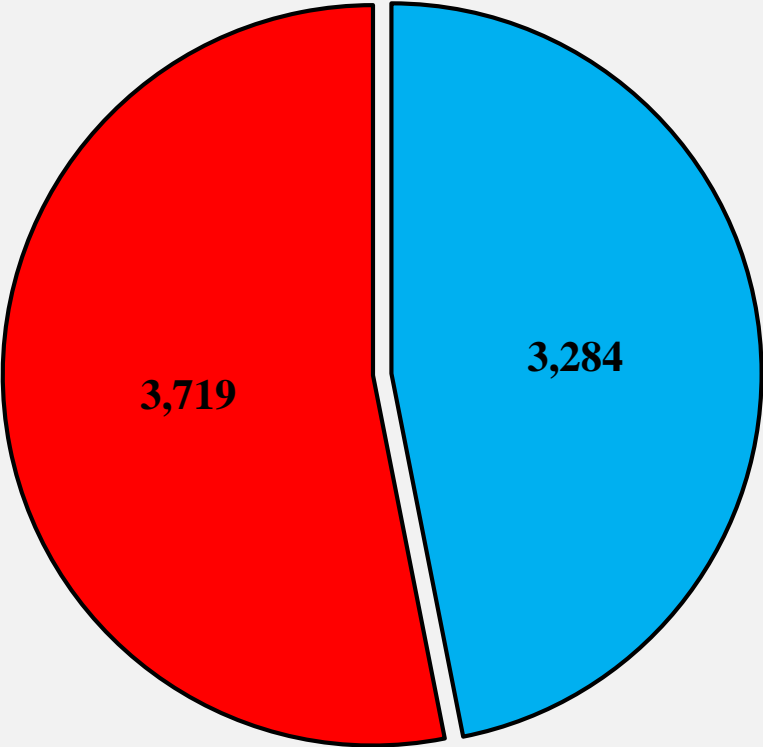
COVID-19 Cases and Deaths by Gender

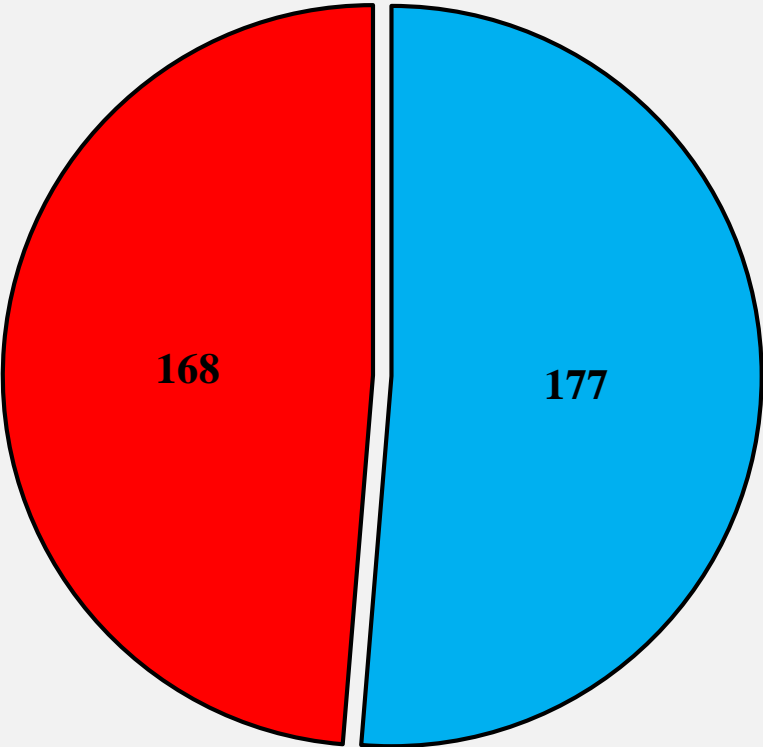

Cumulative Confirmed Cases



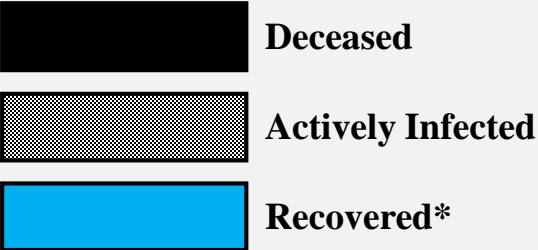
Cumulative Deaths



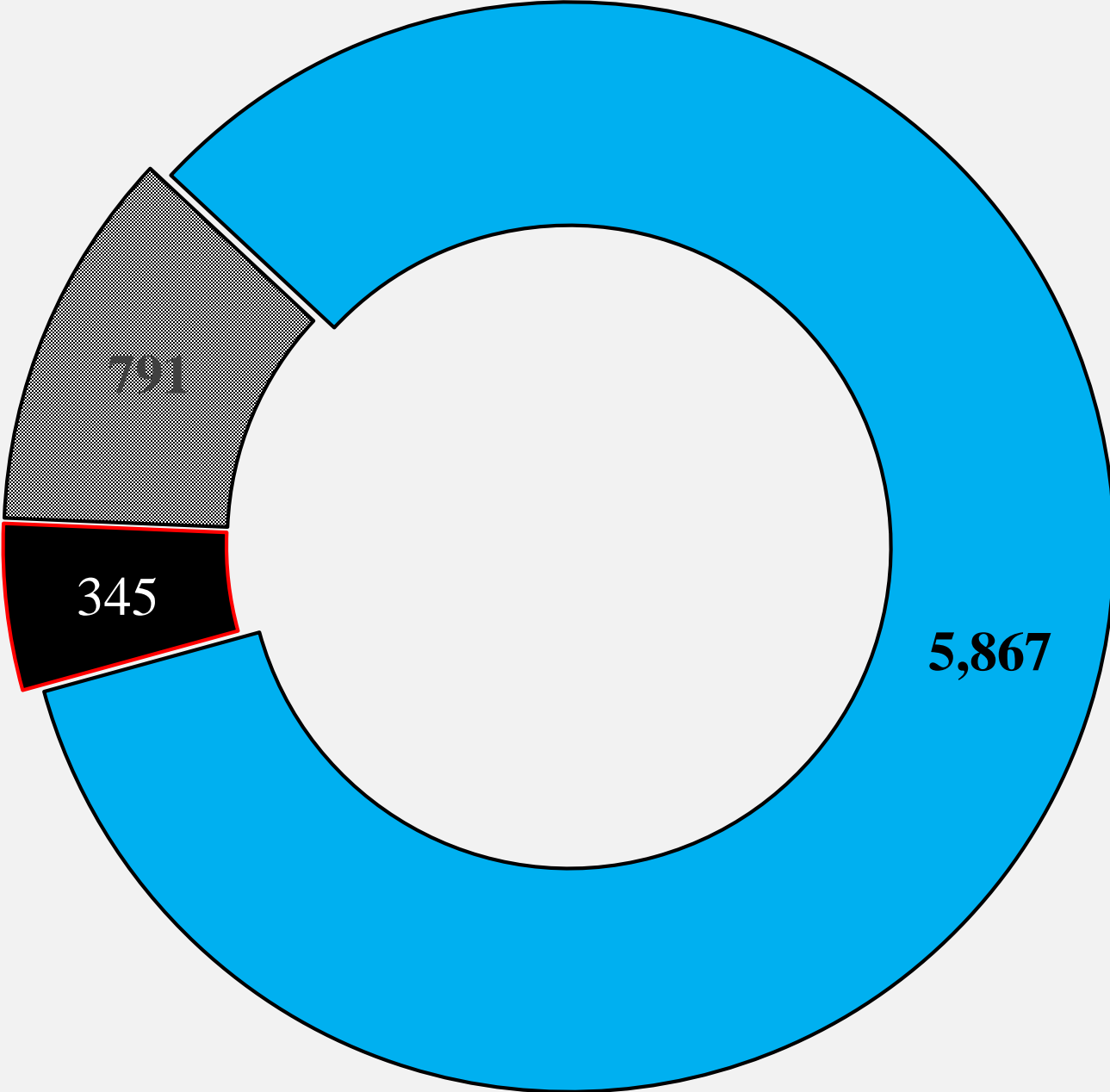

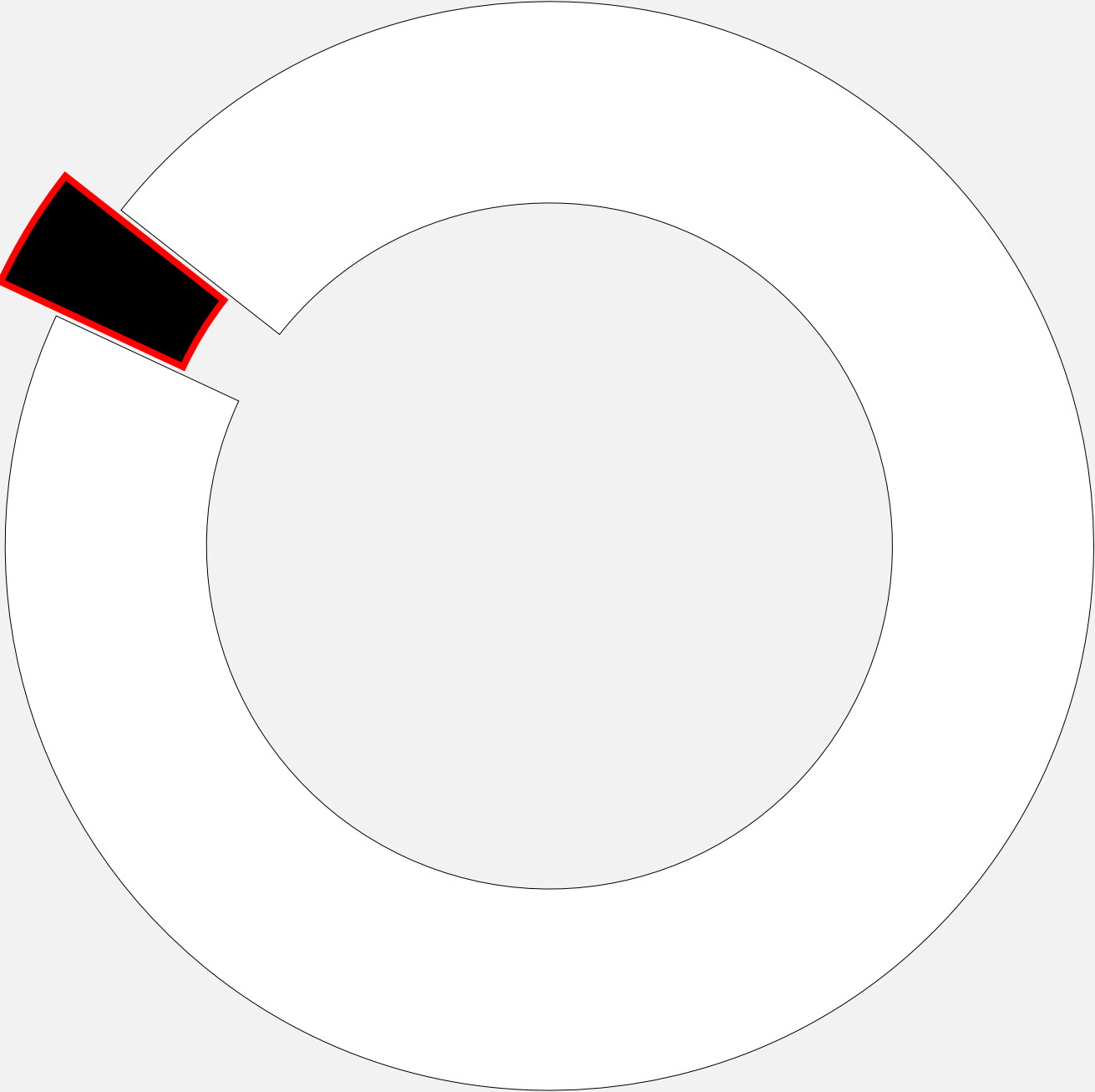

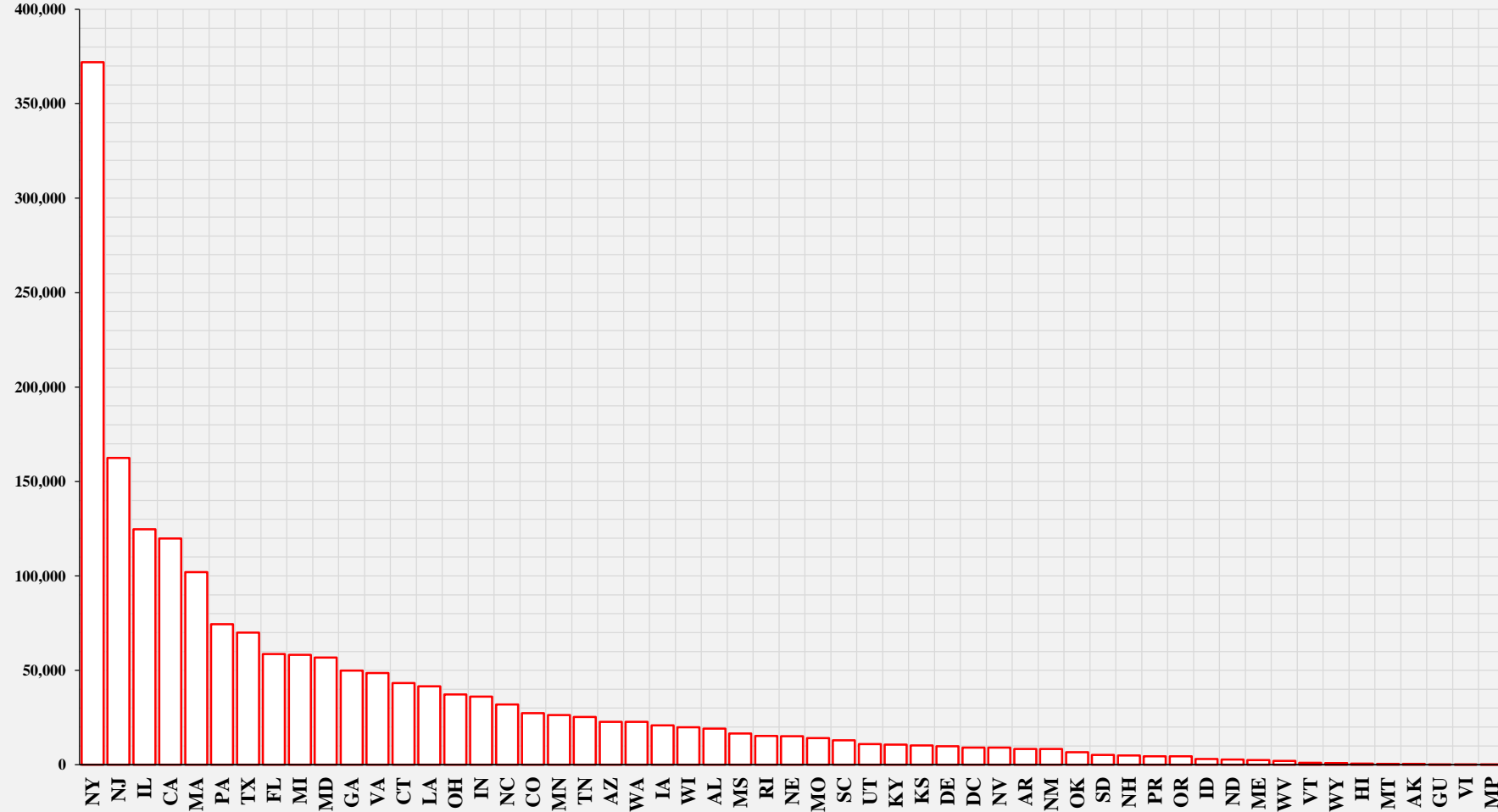
COVID-19 Cumulative Confirmed Cases by U.S. State, Territory

■ Claims

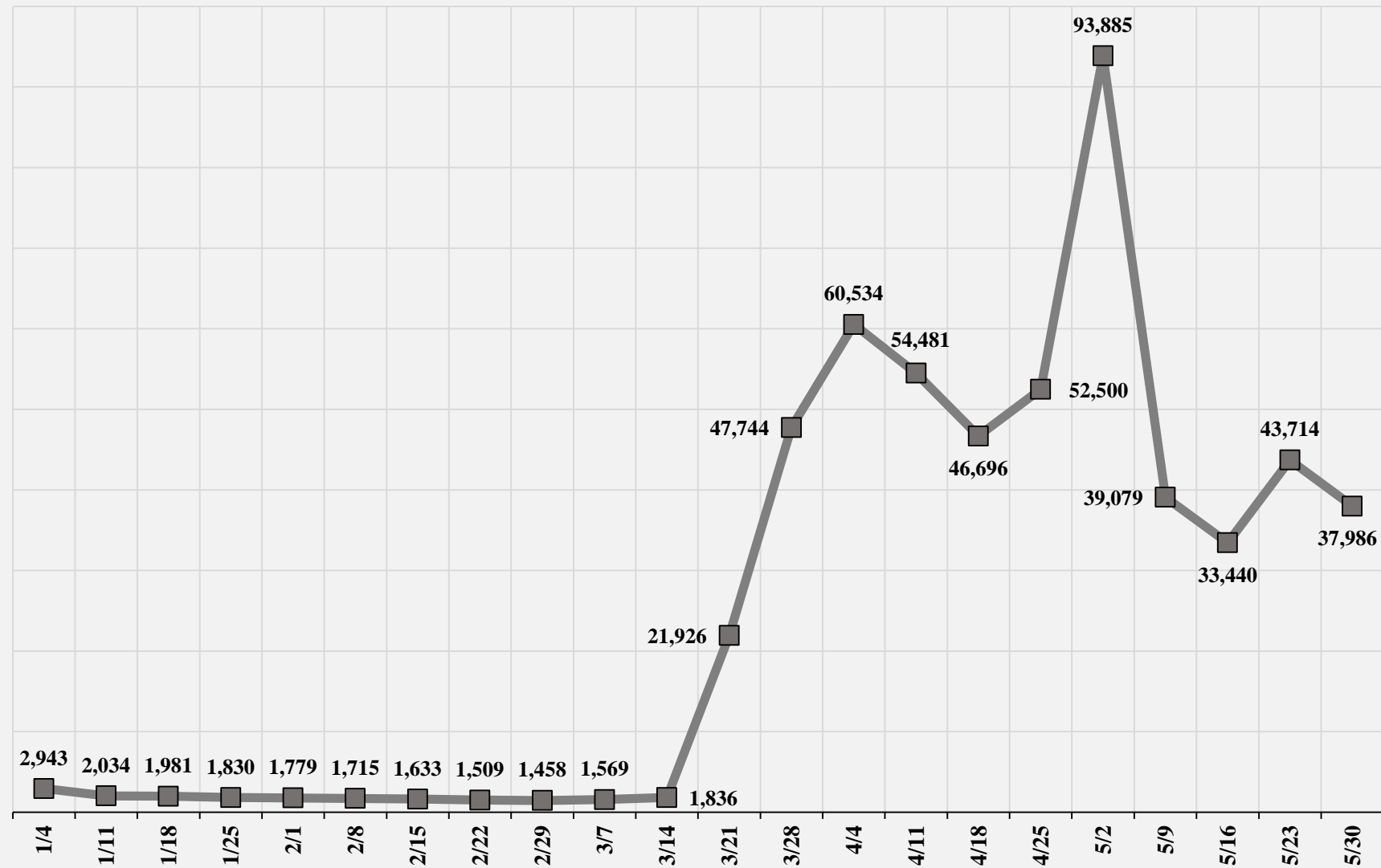
Unemployment claims are reported on a weekly basis every Thursday by the U.S. Department of Labor. New data published 6/4/2020:

- Reported 37,986 initial claims filed in Oklahoma during the week ending 5/30/2020
- Revised upwards by 11,587 claims filed during the week ending 5/23/2020

Each of these numbers represents the number of new unemployment claims filed in Oklahoma each week; they are **not** cumulative.

The weekly data is released, prior week data is subject to revision by the U.S. Department of Labor.

The data used here is not seasonally adjusted.
