Resolution authorizing the submission of an application for 2015 Continuum of Care Federal grant funds to the United States Department of Housing and Urban Development, and accepting the recommendations of the Continuum of Care Board to include: City Rescue Mission, Inc. (Supportive Housing Renewal), \$93,879; Be The Change, Inc. (Supportive Housing Renewal), \$78,454; City Care, Inc. (Supportive Housing Renewal), \$193,340; City Care, Inc. (Transitional Housing Renewal), \$305,715; Hope Community Services, Inc. (Supportive Housing Renewal), \$19,166; Hope Community Services, Inc. (Supportive Housing Renewal), \$244,033; Red Rock Behavioral Health Services, Inc. (The Lodges - Supportive Housing Renewal), \$134,397; The Homeless Alliance, Inc. (Supportive Housing Renewal), \$436,388; Hope Community Services, Inc. **Purpose** To submit an application for a competitive Federal Grant. No City match will be required if the grant is awarded.

**Background** An Open Solicitation was issued on September 25, 2015, that sought proposals from non-profit agencies willing to participate in the response to the Notification of Funding Availability (NOFA) for the 2015 Continuum of Care grant. On October 14, 2015, 23 proposals were received.

The Continuum of Care Board met on October 22, 2015 and completed an evaluation of all applications. After interviewing all applicants, the Continuum of Care Board recommended inclusion of 22 of the 23 proposals.

All applicants were informed of the Council Social Services Committee meeting on October 30, 2015. The Social Services Committee unanimously recommended the following agencies for inclusion in the application:
