**RESOLUTION**

**RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY PROPOSING AMENDMENTS TO THE CHARTER OF THE CITY OF OKLAHOMA CITY, AS AMENDED; CALLING A SPECIAL ELECTION TO SUBMIT THE PROPOSED CHARTER AMENDMENTS TO THE REGISTERED VOTERS OF THE CITY; SETTING THE DATE OF NOVEMBER 3, 2020, FOR THE SPECIAL ELECTION; AND DIRECTING THAT NOTICE OF THE PROPOSED CHARTER AMENDMENTS AND SPECIAL ELECTION BE GIVEN BY THE CITY CLERK BY PUBLICATION OF NOTICE AS REQUIRED BY LAW.**

**WHEREAS**, the Council of The City of Oklahoma City believes that amendments to the Charter of The City of Oklahoma City, as amended, should be adopted; and

**WHEREAS**, Section 13-111 of Title 11 of the Oklahoma Statutes provides that amendments to a municipal charter may be proposed by resolution of the municipal governing body of the municipality; and

**WHEREAS**, the Council desires to propose the Oklahoma City Charter amendments attached hereto as Exhibits A-1 through A-9, inclusive; and

**WHEREAS**, the Council further desires to call a special election to submit the proposed Oklahoma City Charter amendments to the registered voters of The City of Oklahoma City for their approval or disapproval; and

**WHEREAS**, the Council further desires to set a date for the special election; and

**WHEREAS**, the Council further desires to provide gists of the proposed Oklahoma City Charter amendments in the form of special election ballot propositions, which are attached hereto as Exhibits B-1 through B-9, inclusive; and

**WHEREAS**, the Council further desires to direct that notice of the proposed Oklahoma City

Charter amendments and special election be published by the City Clerk as required by law.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of The City of Oklahoma City proposes that the Oklahoma City Charter be amended by adoption of the amendments fully set forth in Exhibits A-1 through A-9, inclusive, attached to and incorporated by reference into this Resolution.

**AND, BE IT FURTHER RESOLVED** that the Council hereby calls a special election to be held within The City of Oklahoma City to submit the proposed amendments to the Oklahoma City Charter (attached Exhibits A-1 through A-9, inclusive) to the registered voters of Oklahoma City for their approval or disapproval; and, further, that the Council hereby designates November 3, 2020, as the date for the special election to be held within The City of Oklahoma City, Oklahoma.

**AND, BE IT FURTHER RESOLVED** that the Council hereby provides gists of the proposed Oklahoma City Charter amendments in the form of the special election ballot propositions attached hereto as Exhibits B-1 through B-9, inclusive, which propositions shall be submitted to the registered voters of The City at the November 3, 2020 special election.

**AND, BE IT FURTHER RESOLVED** that the Council hereby directs the City Clerk to publish Notice of the proposed Charter amendments set forth in Exhibits A-1 through A-9, inclusive, plus the date of the special election on such amendments, in a daily newspaper of general circulation within The City of Oklahoma City, with such Notice to be published a sufficient number of times to comply with the notice requirements of Article 18, Section 3(a) of the Oklahoma Constitution and Section 13-106 of Title 11 of the Oklahoma Statutes.

**AND, BE IT FURTHER RESOLVED** that the Council hereby further directs the City Clerk to publish this Resolution in full, plus attachments, twice in a daily newspaper of general circulation within The City of Oklahoma City in compliance with 16-101 of Title 11 of the Oklahoma Statutes, with the two days of such publication to be October 21 and 28, 2020.


