










COVID-19 Oklahoma City Cases Per Day

4/18 through 10/1/2020




COVID-19 Oklahoma City Deaths Per Day




COVID-19 Oklahoma City Cases 30-Day Trends


COVID-19 Oklahoma City Deaths 30-Day Trends


Deaths Per Day




COVID-19 Active Cases by Oklahoma City ZIP




COVID-19 Statewide Cases, Hospitalizations, and Deaths Per Day

This chart demonstrates cases, hospitalizations, and deaths reported daily rather than cumulative based on the Oklahoma State Health Department's daily reports.




COVID-19 Statewide Cases 30-Day Trends


COVID-19 Statewide Hospitalizations 30-Day Trends




COVID-19 Statewide Deaths 30-Day Trends


















COVID-19 Cumulative Confirmed Cases by U.S. State, Territory


Unemployment claims are reported on a weekly basis every Thursday by the U.S. Department of Labor.


New data published 10/1/2020:

- Reported 4,512 initial claims filed in Oklahoma during the week ending 9/29/2020
- Revised downwards by 126 claims filed during the week ending 9/19/2020

Each of these numbers represents the number of new unemployment claims filed in Oklahoma each week; they are **not** cumulative. When weekly data is released, prior week data is subject to revision by the U.S. Department of Labor.

The data used here is not seasonally adjusted.
