








COVID-19 Oklahoma City Cases Per Day




COVID-19 Oklahoma City Deaths Per Day




COVID-19 Oklahoma City Deaths 30-Day Trends







COVID-19 Active Cases by Oklahoma City ZIP




COVID-19 Statewide Cases, Hospitalizations, and Deaths Per Day

This chart demonstrates cases, hospitalizations, and deaths reported daily rather than cumulative based on the Oklahoma State Health Department's daily reports.




COVID-19 Statewide New Daily Cases 30-Day Trends




COVID-19 Statewide New Daily Hospital Admissions 30-Day Trends




COVID-19 Statewide New Daily Deaths 30-Day Trends






COVID-19 Statewide Cases and Deaths by Age Cohort






COVID-19 Cases and Deaths by Race and Ethnicity












COVID-19 Cumulative Confirmed Cases by U.S. State, Territory

Unemployment claims are reported on a weekly basis every Thursday by the U.S. Department of Labor.


New data published 11/5/2020:

- Reported 4,255 initial claims filed in Oklahoma during the week ending 10/31/2020
- Revised downwards by 63 claims filed during the week ending 10/24/2020

Each of these numbers represents the number of new unemployment claims filed in Oklahoma each week; they are **not** cumulative. When weekly data is released, prior week data is subject to revision by the U.S. Department of Labor.

The data used here is not seasonally adjusted.





Note: Oklahoma's unemployment system has seen a large but still unclear quantity of fraudulent claims. The Oklahoma Employment Security Commission (OESC) and their benefits distribution contractor were reported to have "identified about 70,000 claims as being fraudulent." On Monday, June 22nd, the OESC interim director stated since March 1st, "about 64,000 claims," or about 10% of all claims statewide, were identified as potential fraud and stopped; prior stories reported "100,000 have been viewed as fraudulent" with "nearly 15,000 fictitious claims" linked to "a well-organized Nigerian fraud ring." The Oklahoma Employment Security Commission has set-up a website solely for the purpose of intaking reports of unemployment fraud.
