



Heavy Industrial District

The I-3 District is intended to provide locations for those industrial uses that may generate relatively high levels of noise, vibrations, smoke, dust, odor or light. These industrial uses are incompatible with residential uses. For this reason it is desirable that they be located downwind, and as far away as possible, from residential and most commercial uses.
