



FY 16 Budget Overview


General Fund: \$3,903,539

ISSUE Community Development

Poverty, homelessness, lack of quality affordable housing, decreasing community involvement in neighborhood schools, and declining community vitality



STRATEGIES

Address homelessness, community vitality and lack of quality affordable housing by

- Concentrating Community
 Development resources in targeted revitalization areas
- Expanding tools and funding for affordable housing
- Stabilizing at risk neighborhoods through the Strong Neighborhoods Initiative
- Achieving homeless remain in permanent supportive housing for more than 6 months


Continuum of Care Program

- Completed plans and studies

- Provided funding or assistance for
 - 27 new homes
 - 25 whole house rehabs
 - 35 home exterior maintenance projects
 - 100 emergency home repairs
 - 250 environmental reviews
 - 10-12 storm damage relief projects
 - 57 storm shelters



ISSUE Urban Revitalization

The last few decades of development focused on the outer perimeter of the city has left our inner loop vulnerable and in decline



STRATEGIES

Influence revitalization and redevelopment within the urbanized areas of the city by

- Implementing existing plans
- Increasing business/residential activity & property values downtown
- Strengthening commercial districts
- Concentrating neighborhood revitalization efforts
- Targeting Brownfields resources
- Enhancing design standards in downtown and other urban design districts

ISSUE Sustainable Growth

Development that does not incorporate sustainability principles that promote a balance among economic growth, environmental health, socio-economic and financial considerations



STRATEGIES

Ensure future development achieves a more sustainable balance by

- Adopting and implementing impact fees
- Increasing mixed market housing development
- Promoting inner-city development and redevelopment
- Putting vacant and abandoned buildings back into productive use
- Modifying development codes and guidelines




