SUBJECT: SEPTEMBER 2015 SALES AND USE TAX COLLECTIONS

Combined sales and use taxes for the General Fund are \$3,176,624 or 4.8% below target for the year.

General Fund Sales Tax

Note: With the passing of House Bill 1875 on July 1, 2015, the retention fee paid to the Oklahoma Tax Commission for collection of sales and use taxes decreased from 1% to 0.5%. Overall comparisons of sales tax will include the additional 0.5%, while comparisons of specific categories will not be affected.


General Fund sales tax collections for September totaled \$18,556,793, which is:

- \$185,924 or 1.0% below target for the month
- \$342,296 or 1.9% above FY 2015 collections for the month

The September remittance includes actual collections for the second half of July and estimated collections for the first half of August by major taxpayers.

Favorable sales tax growth in most industries was hindered this month by declines in Other Miscellaneous and Manufacturing. As the prices of oil and gas have dropped, so have sales from oil and gas related businesses. Much of the declines experienced in Other Miscellaneous and Manufacturing were due to oil and gas related businesses.

Comparison to Other Cities

Sales tax collections for all but three of the top twenty cities in Oklahoma were up from last year. Oklahoma City's sales tax growth was on the lower end of the spectrum. Reduced sales from businesses related to the oil and gas industry likely affects Oklahoma City more than most.

Retail

- General Merchandise It was a good month for most merchandisers as a solid majority experienced sales above those of last year.
- Building Materials Several of the major businesses in this category reported notable increases in sales from last year.
- Electronics & Appliances Most did well; however, some new additions to the category helped push sales growth higher.
- Miscellaneous Retail A single oil and gas related business was responsible for almost the entire drop in sales.
- Furniture & Home The majority of businesses in the category reported declines in sales from last year.
- Sporting Goods & Hobby Stores The majority of businesses reported sales declines from last year. One business was responsible for about two-thirds of the decline.

Other Major Categories

- Hotels & Restaurants increased 7.4% from last year.
 - Hotels edged up 2.6%. Sales favored the smaller hotels more so than the larger ones.
 - Eating & Drinking Establishment's 8.3% growth was due to a large refund last year.
- Services grew 2.5%. Most subcategories reported growth.
- Wholesale declined 2.6% with the majority of taxpayers reporting decreases in sales.
- Utilities grew 10.2%. Sales were up for both electricity and natural gas.
- Manufacturing fell 12.1%. Sales were down for most manufacturers, but three-fourths of the decline was caused by one business.
- Other Miscellaneous sank 55.8%. Nearly two-thirds of the decline is due to one business in Mining. They had a large payment last year and a refund this year.


General Fund Use Tax

General Fund use tax collections for September totaled \$2,871,447 which is:

- \$325,273 or 10.2% below target for the month
- \$394,019 or 12.1% below FY 2015 collections for the month

Most of the drop this month is due to businesses that are related to the oil and gas industry. Over half of this month's decline is due to one oil and gas business in Wholesale.
