

OKC Development Codes Update

Phase 2: Code Development (Ongoing)

Code Development: The City's consultant team led by White & Smith Planning and Law Group of Kansas City, Mo., with subconsultants Kendig Keast and Vireo, are creating a code framework, overseeing public input and engagement, and will draft new codes and regulations and graphics to replace the existing Zoning and Planning Code (Chapter 59 of the Oklahoma City Municipal Code), sign regulations (Chapter 3, Article V of the



Oklahoma City Municipal Code), and the Oklahoma City Subdivision Regulations. Phase 2 is a multi-year process that includes multiple opportunities for community-wide feedback in the form of surveys, focus groups on specific topics, and workshops to take place in 2021 and 2022.

Surveys: Consultants and City staff are excited to hear from residents and business owners about how Oklahoma City should look and develop in the future. The first survey was launched in August of 2021. Please take surveys by Oct. 2, 2021. Answers will help to prioritize development issues in rural areas of the City, inside the core, outside the core and in downtown. Help us prioritize! Take one, two, three or all four surveys.

Sign Regulations: (Chapter 3, Article V of the Oklahoma City Municipal Code). The first step in the Code Update process relates to the City's sign regulations. The goals of updating the sign regulations are to create a highly graphic and user-friendly code layout, to reduce sign clutter across the City, and to improve the aesthetics of signs. Several focus groups were held in 2020 to get feedback on signs. These included the Stakeholder Advisory Team, sign industry professionals, city staff and neighborhood representatives.
