APPLICATION PROCESS

The Mayor is receiving applications for volunteers to be appointed to Committees and Commissions staffed by the Oklahoma City Planning Department. The Mayor appoints positions intermittently throughout the year as vacancies occur. Applications may be submitted at any time, but will not be retained past December 31st of each calendar year. In order to maintain a current application for consideration, you may need to resubmit a new application at the beginning of each year.
