

ORDINANCE NO. 155

An Ordinance adding certain territory to the City of Oklahoma City and declaring the entire boundry of said city as changed by the addition of said territory.

Whereas, The southwest quarter of section 34, township 12 north, range 3 west I. M., a tract of land lying adjoining to the city limits of the City of Oklahoma City, has been subdivided into lots, blocks, streets and alleys, and a plat of the same has been filed in the office of the Register of Deeds of Oklahoma County, Oklahoma Territory, which said tract of land is known and designated as the Military Addition to the City of Oklahoma City; Therefore, be it ordained by the Mayor and Councilmen of the City of Oklahoma City:

Sec. 1. That all that tract of land known as the Military Addition to the City of Oklahoma City, according to and as the same is described by the plat now on file in the office of the Register of Deeds in Oklahoma County, Oklahoma Territory, be and the same is hereby added to the City of Oklahoma City, and made to all intents and for purposes contemplated in the law under which said city is organized, a part of said city. The plat of the above described addition has been heretofore approved by the Mayor and City Council.

Sec. 2. That all of said territory hereby added to the City of Oklahoma City which lies contiguous to the first ward and north of the alley between Main and Grand Avenue streets, is hereby added to the first ward of said city, and all of said territory lying contiguous to the fourth ward of said city and south of said alley between Main and Grand Avenue streets is hereby added to the fourth ward of said city; and all Ordinances, rules and regulations now in force in the City of Oklahoma City shall be,

and the same are hereby declared to be in full force and effect in the territory added to the city by this Ordinance.

Sec. 3. That hereafter ~~x~~ <sup>the</sup> corporate limits and entire boundary of the City of Oklahoma City shall be as follows to wit: Commencing at the northwest corner of the southwest quarter of section 34, township 12 north, range 3 west, I. M., Oklahoma Territory, running thence east on the one-half section line to the northeast corner of the southwest <sup>of said</sup> quarter section 34; thence south on the quarter-section line to the southeast corner of the southwest quarter of said section 34; thence west to the southwest corner of said section 34; thence south on section line to the southeast corner of the northeast quarter of section 4, township 11, north, range 3 west, I. M.; thence west to the southwest corner of the northeast quarter of said section 34; thence north on the ~~one-half section~~ line to the ~~northwest~~ corner of the south one-half of the northeast quarter of section 33, township 12, north of range 3, west I. M.; thence east to the northeast corner of the south one-half of the northeast quarter of said section 33; thence south to the northwest corner of the southwest quarter of section 34, township 12, range 3 west to the place of beginning and including the following described land: The south one-half of the northeast quarter and the southeast quarter of section 33, and the southwest quarter of section 34, township 12, range 3 west of the I. M., and the northeast quarter of section 4, township 11, range 3 west of the I. M. The boundaries as above described shall be and constitute the entire boundary of said city as changed by the addition of the territory added by this ordinance, and the corporate limits of said city shall include the territory as above described.
