NOTICE IS HEREBY GIVEN, that the City of Oklahoma City has public improvement work that requires the professional services of a consulting firm ("Consultant").

In order to be considered, the Consultant must timely submit a Letter of Interest as provided herein and comply with the Resolution establishing procedure for "Selection of Architects, Engineers, and Planners" adopted by the City Council on November 18, 1986, a copy of which may be obtained at [www.okc.gov/departments/public-works/engineer-architect-resources/notice-to-a-e/consultant-selection-procedures](http://www.okc.gov/departments/public-works/engineer-architect-resources/notice-to-a-e/consultant-selection-procedures). **Project Title: SC-1078, Sanitary Sewer Rehabilitation, Lightning Creek from SE 15th Street to SE 17th Street**

**Scope of Work:** This project will remove approximately 240 linear feet of 54-inch sanitary sewer aerial crossing and abandon approximately 1,190 linear feet of 54-inch sanitary sewer mains. This area of sanitary sewer mains is required to be eliminated after the installation of a 72-inch sanitary sewer relief line. The consultant will provide final design, bidding, construction administration, inspection, and as-built drawing services necessary to complete the project. A project map and description are posted at [www.okc.gov](http://www.okc.gov).

**Estimated Construction Cost \$600,000**

**Time Schedule for the above project: Task 1 - Preliminary Engineering Report will not be required for this project. Task 2 - Final Plans and Specifications due within one hundred twenty days (120) after the issuance of the Notice to Proceed.**



The Consultant may not change the Project Team without prior consent of the City Engineer. **Please provide a contact name and email address in your Letter of Interest.**

**Project Title:** Sanitary Sewer Rehabilitation

**Project Location:** Lightning Creek from SE 15th Street to SE 17th Street

**Project Number:** SC-1078

**Estimated Construction Cost:** \$600,000

**Background:** The Oklahoma City Water Utilities Trust operates and maintains its wastewater treatment and collection system. This project will remove approximately 240 linear feet of 54-inch sanitary sewer aerial crossing and abandon approximately 1,190 linear feet of 54-inch sanitary sewer mains. This area of sanitary sewer mains is required to be eliminated after the installation of a 72-inch sanitary sewer relief line. Removal and abandonment of these mains is essential to minimize impacts to Lightning Creek and meet regulatory requirements.

**Project Intent:** The consultant for this project will provide final design, bidding, construction administration and management, inspection, and as-built drawing services necessary to complete the project. Preliminary engineering or an engineering report will not be required for this project.
