Resolution approving contract with Brookville Equipment Corporation, Project M3-S005, MAPS 3 Modern Streetcar vehicles, \$24,894,508.

Background As a part of the MAPS 3 Program, The City of Oklahoma City will construct/purchase a new downtown modern streetcar system. Due to the unique nature of this project and the streetcar design options, the City desires to review and select a streetcar that best meets the City's needs.

A request for proposals was issued in August 2014 to purchase a base quantity of five vehicles with an option of up to eight additional modern streetcar vehicles and associated goods and services, such as, but not limited to, spare parts, training materials, parts and maintenance manuals, special tools, and diagnostic equipment as specified.

Seven proposals were received from four manufacturers on November 18, 2014. The Evaulation Committee met and ranked the proposals as follows:

1. INEKON GROUP, a.s.

2. Brookville Equipment Corporation (Narrow Carbody, Resiliently Mounted Traction Motor)

3. Brookville Equipment Corporation (Wide Carbody, Resiliently Mounted Traction Motor)

4. CAF USA, Inc.

5. Xiangtan Electric Manufacturing Corporation Ltd. (XEMC)

Brookville Equipment Corporation submitted two additional proposals (both Rigidly Mounted Traction Motor proposals) but these were not ranked due to the specification requirement for resiliently mounted motors. The Evaulation Committee recommended a contract be negotiated with INEKON GROUP, a.s. to supply five streetcars.

After several months of negotiations, INKEON GROUP was unable to meet specific requirements set forth in the request for proposals, nor was it able to meet the conditions precedent it agreed to in order to form a valid contract with the City.

	Because INKEON GROUP was unable to comply with the conditions precedent, the conditional contract was null and void and no contract was ever formed. Staff was then authorized to negotiate a contract with Brookville Equipment Corporation.
	The MAPS 3 Citizens Advisory Board recommended approval on February 24, 2016.
