Scope of Work: PC-0742 - The consultant will provide design services for pedestrian safety improvements including an ADA-compliant path and amenities (i.e. trash receptacles, benches, bus stops, shelters, shade structures, lighting, etc.), on the north and south sides of NE 23rd Street between Kelley Avenue and Miramar Boulevard/Katy Trail. Included in the design services are intersection improvements, street lighting and landscaping along the corridor. The consultant should include a cultural engagement consultant and work with cultural stakeholders/representatives from northeast OKC to perform public outreach bringing together community interests to address challenges and opportunities.
