

## APPLICATION FOR LICENSING OF RETAIL DEALER OF LOW-POINT BEER

### I. To Be Completed by All Applicants

The answers to each of the following three questions must be "yes" (indicated by checking the box to the left of each) and the applicant must attach the referenced documents to receive a low-point beer license. After completing this section, proceed to section II for a Consumption Off the Premises License OR section III for a Consumption On the Premises License.

1. Does the Applicant have a Sales Tax Permit from the Oklahoma Tax Commission and a Low Point Beer License (Draught-Bottle-Can) from the Oklahoma Tax Commission for the sale or serving of Low Point Beer? If not, please check with the representative at the Permit Counter. If so, please attach a copy of the Oklahoma Tax Commission permit and license and check the box to the left.
2. Does the Applicant have a County Beverage Permit to sell Low-Point Beer for Consumption on/off the Premises? If not, please check with the representative at the Permit Counter. If so, please attach a copy of the County Beverage Permit and check the box to the left. NOTE: The name of the Applicant and the Address of the Premises on both the Oklahoma Tax Commission Low Point Beer License and the County Beverage Permit shall match, and this name and address will be used in any license issued by The City of Oklahoma City.
3. Has the Applicant submitted an Affidavit attesting that sales and consumption of alcoholic beverages on premises has not ceased for a period of time exceeding six months at the Premises? If not, please check with the representative at the Permit Counter. If so, please attach the original Affidavit and check the box to the left.

### II. Off-Premises Consumption

If the Applicant is seeking a license to sell low-point beer for consumption only off of the Premises, please check the box below to the left and proceed directly to the signature line at the end of this application. If you did not check this box, please proceed to section III, On-Premises Consumption.

- Class 1 License.** If you check this box, you will be issued a Class 1 License for sale of low-point beer for consumption OFF of the premises. NO PERSON SHALL BE PERMITTED TO CONSUME LOW-POINT BEER OR ALCOHOLIC BEVERAGES ON THE LICENSED PREMISES.

### III. On-Premises Consumption

If the Applicant is seeking a license to sell or serve low-point beer for consumption on the Premises, please read the following paragraphs carefully because the type of license you will be issued depends upon the nature of the business as defined by State law, particularly Oklahoma Statutes, Title 37, Sections 213, 241, 243 and 246. If you check any one of the boxes below, leave the remaining boxes blank and proceed directly to the signature line at the end of this application.

- Class 8 License.** If the business or establishment located on the Premises has as its main purpose the sale of low-point beer, not including admission charges, check the box to the left. If you check this box, you will be issued a Class 8 License for the sale of low-point beer on the licensed premises. **NO PERSON UNDER THE AGE OF 21 YEARS SHALL BE PERMITTED TO ENTER THE PREMISES.** If you did not check this box, please proceed to the next question.

Does the applicant wish to include admission charges in the calculation of the main purpose of the business or establishment located on the Premises? If so, check only one of the following three boxes.

- Class 6 License.** If only persons 18 years of age or older will be permitted to enter the licensed Premises in accordance with 37 O.S. § 246 and the Applicant has determined, including admission charges, that the main purpose of the business or establishment is some objective other than the sale of low-point beer, check the box to the left. If you check this box, you will be issued a Class 6 License. **PERSONS UNDER 18 YEARS OF AGE SHALL NOT BE PERMITTED TO ENTER THE PREMISES. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER.**
- Class 5 License.** If the Premises are owned or operated by a service organization or fraternal establishment which is exempt from income taxation under Internal Revenue Code Section 501(c)(19), (8) or (10), and the Applicant has determined, including admission charges, that the main purpose of the business or establishment is some objective other than the sale of low-point beer, check the box to the left. If you check this box, you will be issued a Class 5 License. **ALL PERSONS MAY BE PERMITTED TO ENTER THE PREMISES. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER.**
- Class 2 License.** If the Premises are located on public event facilities owned or operated by an agency, political subdivision or public trust of the State of Oklahoma, and the Applicant will sell, distribute or dispense low-

point beer at public events, and the Applicant has determined that the main purpose of the public event facilities, including admission charges, is some objective other than the sale of low-point beer, check the box to the left. You may be asked to provide a copy of your lease or permit to use the public event facilities. If you check this box, you will be issued a Class 2 License. ALL PERSONS MAY BE PERMITTED TO ENTER THE PREMISES. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER.

If you did not check any of the three boxes above, proceed to the following question.

**Class 3 License.** If the revenue generated by the sale of low-point beer at the business or establishment located on the Premises is or will be less than 25 percent of the revenue generated by the business or establishment, not including admission charges, check the box to the left. If you check this box, you will be issued a Class 3 License. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER. THERE ARE NO AGE RESTRICTIONS CONCERNING WHO CAN ENTER THE PREMISES OR WHO CAN WORK, EXCEPT NO PERSON UNDER 21 YEARS OF AGE CAN WORK IN OR ENTER AN ENCLOSED BAR AREA. . If you did not check this box, please proceed to the next question.

**Class 7 License.** If the revenue generated by the sale of low-point beer at the business or establishment located on the Premises is or will be greater than 25 percent but less than 50 percent of the revenue generated by the business or establishment, not including admission charges and no minors under the age of 18 will be employed in the business or establishment located on the premises, check the box to the left. If you check this box, you will be issued a Class 7 License. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER. THERE ARE NO AGE RESTRICTIONS ON PERSONS ENTERING THE PREMISES. NO PERSON UNDER 18 SHALL BE EMPLOYED OR PERMITTED TO WORK ON THE PREMISES. . If you did not check this box, proceed to the next question.

**Class 4 License.** If the revenue generated by the sale of low-point beer at the business or establishment located on the Premises is or will be greater than 25 percent but less than 50 percent of the revenue generated by the business or establishment, not including admission charges and if the Applicant wishes to employ his or her children under the age of 18 on the Premises in accordance with 37 O.S. § 243, check the box to the left. If you check this box, you will be issued a Class 4 License. ONLY PERSONS OVER 21 YEARS OF AGE SHALL BE PERMITTED TO PURCHASE OR DRINK LOW-POINT BEER. THERE ARE NO AGE RESTRICTIONS CONCERNING WHO CAN ENTER THE PREMISES. . NO PERSON UNDER 18 SHALL BE EMPLOYED OR PERMITTED TO WORK ON THE PREMISES except the following children of the Applicant:
