KNOW ALL MEN BY THESE PRESENTS:

That we, _____ as Principal,

 are held and firmly bound unto The City of Oklahoma City, a Municipal Corporation of the State of Oklahoma, in the sum of One Thousand Dollars(\$1,000.00), lawful money of the United States of America, for the payment of which well and truly to be made, we bind ourselves, our successors, heirs, executors, administrators and assigns jointly and severally, firmly by these presents

NOW, the conditions of this obligation are such that whereas, the above bounden principal obligor has made an application for license to carry on the business or trade of "Used Trailer or Used Automobile or Merchandise Salvage Dealer or Dealer in Secondhand or Used Automobile Parts and Accessories" within the City of Oklahoma City, for the period of the license paying year within said City, beginning _____, 20____, and ending _____, 20____, under and pursuant to the requirements of the Codes of said City regulating and registering the trade or occupation of Used Trailer or Used Automobile or Merchandise Salvage Dealer or Dealer in Secondhand or Used Automobile Parts and Accessories", above mentioned and in which application the applicant guarantees, upon the granting of said license, that he will comply faithfully with the provisions of said Code in all respects and will also comply fully with all other Codes of said City affecting such business occupation, which may now exist or which may be passed by the lawful authorities of said City during the continuation of said license, and such Codes and all other Codes of said City affecting said occupation are hereby made a part of the obligation of this bond and are to be performed by the principal hereof as though fully transcribed herein, and that the principal obligor will pay all costs, fines and penalties incurred on account of his failure or neglect in observing all Codes, regulations and requirements, stated herein, of said City, and will pay all damages resulting to any person by reason of his wrongfully taking, purchasing, or receiving in pledge or on deposit any stolen property, or the property of any minor.

NOW, if the said _____ principal obligor, shall fully and faithfully perform all the duties appertaining to such activity fully in accordance with the Codes herein mentioned while doing or following said occupation, activity, or business within the corporate limits of The City of Oklahoma City, and if said principal obligor shall, during the term of said license, faithfully comply with all the rules and regulations of the lawful officers of said City and penalties imposed for a violation of any of said Codes, and shall pay all damages resulting to any person by reason of his wrongfully taking, purchasing, or receiving in pledge or on deposit any stolen property, or the property of any minor then this obligation to be void and of no effect, otherwise to remain in full force and virtue.
