NOTICE IS HEREBY GIVEN, that the City of Oklahoma City has public improvement work that requires the professional services of a consulting firm ("Consultant").

In order to be considered, the Consultant must timely submit a Letter of Interest as provided herein and comply with the Resolution establishing procedure for "Selection of Architects, Engineers, and Planners" adopted by the City Council on November 18, 1986, a copy of which may be obtained at www.okc.gov/departments/public-works/engineer-architect-resources/notice-to-a-e/consultant-selection-procedures. Project Title: AT-0074, Construction Management Consultant for a New Three-Bay 737 Aircraft Hangar at Will Rogers World Airport

Scope of Work: The consultant will provide construction management services during the construction process for a design/bid/build construction project. During the design phase, the services will include, but not limited to, commenting on, and preparing written documentation for review of design and constructability, cost estimates, final bid documents, quality assurance/control and bids received. During the construction phase, the services will include, but not limited to, preparing a construction management plan, quality assurance/control, change order and amendment management, close-out, schedule adherence, and managing the construction by providing on-site personnel. This project will not include any federal funding. The construction cost is \$40,000,000.

Time Schedule for the above Scope of Work: Design Phase services beginning within four-months of the Notice to Proceed. Planning through final design services is anticipated to be an eighteen- month duration.


