Scope of Work: The Restoration Center will be a new City owned facility managed by an operator and will include a mental health crisis center with a much larger focus on addiction. The facility will include a public inebriate alternative, medically supervised detox, substance abuse counseling, and medication assisted treatment for opioid addiction. The center will also provide a full suite of wrap-around case management services for clients of the facility. Services will include assistance with site selection, planning, design, and construction administration services for the project. The consultant will meet with City officials, the operator, stakeholders, and user groups as well as make presentations to the MAPS 4 Community Subcommittee, MAPS 4 Citizens Advisory Board, and City Council along with the various design review committees as established by ordinance. The estimated construction cost for the Restoration Center is \$17,443,400.

Project Title: M4-MM030, MAPS 4 Transitional Housing

Scope of Work: The MAPS Program will also be providing a transitional housing facility on or near the Restoration Center site. This facility will provide transitional housing services to include short and mid-term housing solutions for individuals transitioning out of a Mental Health Crisis Center, the Restoration Center, or other similar facilities in Oklahoma City. Case management and other 24-hour wrap around services are anticipated to be key elements of programs and services provided to residents during their stay. Services will include assistance with site selection, planning, design, and construction administration services for the project. The consultant will meet with City officials, the operator, stakeholders, and user groups as well as make presentations to the MAPS 4 Community Subcommittee, MAPS 4 Citizens Advisory Board, and City Council along with the various design review committees as established by ordinance. The estimated construction cost for Transitional Housing is \$4,899,800.

One firm will be selected for both projects.
