

ORDINANCE NO. 27,587

AN ORDINANCE RELATING TO GENERAL SCHEDULE OF FEES, REPEALING ARTICLE II – FIRE PREVENTION CODE, TITLE 20 – FIRE PREVENTION AND PROTECTION, SECTIONS 60-20-11 THROUGH 60-20-44 OF CHAPTER 60, OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020, IN ITS ENTIRETY; ENACTING A NEW ARTICLE II – FIRE PREVENTION CODE, TITLE 20 – FIRE PREVENTION AND PROTECTION, OF CHAPTER 60, SECTIONS 60-20-11 THROUGH 60-20-41, ESTABLISHING CERTAIN FEES REQUIRED IN THE FIRE PREVENTION CODE OF THE GENERAL SCHEDULE OF FEES; AND PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. That Article II, Title 20, Chapter 60, Sections 60-20-11 through 60-20-44 of the Oklahoma City Municipal Code, 2020, are hereby repealed in their entirety.

SECTION 2. That Article II, Title 20, Chapter 60 of the Oklahoma City Municipal Code, 2020, is hereby amended by enacting a new Article II, Title 20, Chapter 60, Sections 60-20-11 through 60-20-41 as follows:
