West facade: Shift location of exterior gate doors to the south and add additional exterior gate doors; 2. South facade: Shift westernmost double entrance doors to the east; revise building design at the eastern end to shift building wing walls, widen planter and shift glazed opening to the west; 3. North facade: add one window and move the locations of the other windows; 4. Add two bike racks on Hudson; and 5. Move the location of the two proposed street lights along Hudson.
