

## NOTICE OF ADMINISTRATIVELY APPROVED PROJECTS IN DESIGN REVIEW DISTRICTS

Building projects in the City's design review districts require a Certificate of Approval prior to obtaining a building permit. This report lists projects that have received an administratively approved Certificate of Approval issued by staff of the Oklahoma City Planning Department. Work on approved projects may not commence until after the mandatory 10-business day appeal period starting from the date of approval. This report is mailed to owners of property located within 150 feet of the subject properties listed below.

## **URBAN DESIGN**

**UDCA-24-00035 at 2420 S Robinson Avenue** (Capitol Hill). Application by Chad Hodges, Capitol Co-op, for Gene Rowland, Gene A Rowland Living Trust, to: 1) Install painted sign at the west elevation; 2) Install two projecting wall signs (one at the northwest corner of the building and one at the southwest corner of the building); 3) Install various multiple window signs at the west elevation; 4) Relocate existing lighting fixtures at the west elevation; and 5) Install new metal awning with hangar rods at the west elevation.

**UDCA-24-00036 (Part 1) at 1732 NW 16th Street** (Plaza District). Application by Rob Elliott, Elliott Architects, for Jonathan Dodson, 1732 NW 16, LLC, to: 1) Construct new trash enclosure (with wood fencing to match the existing adjacent wood fence) at the rear of the site; 2) Construct additional wood fencing (to match existing adjacent wood fencing) with a man gate to screen the proposed dry storage and cooler structures; 3) Install dry storage structure; 4) Install cooler structure; and 5) Replace entry door at the north elevation.



**UDCA-24-00037 at 1630 and 1634 N Blackwelder Avenue** (Plaza District). Application by Patrick Struble, Slate Construction, for Jeff Struble, 1630, LLC, to: 1) Install four sun shade screens at the second story of the west elevation at 1630 N Blackwelder Ave; 2) Extend the existing metal canopy at the north elevation of 1630 N Blackwelder to the east by an additional 6½ feet; 3) Construct new metal roof over the existing patio between 1630 and 1634 N Blackwelder Ave; 4) Add 1" x 4" wood siding to the existing railings enclosing the existing patios; 5) Install 8 foot tall galvanized metal posts to support proposed string lighting; and 6) Paint all existing metal awning and railings.

Replace brick veneer with cementitious lap siding; 5. Reduce size of awnings; 6. Change solid railing balconies to picket railing; 7. Replace two overhead doors with storefront windows; 8. Replace a door with a window; 9. Eliminate patio railing; 10. Revise location of handicap parking spaces; 11. Revise location of dumpster enclosure and change to cedar slats; and 12. Revise landscaping to the east of the parking lot.
