Background

In Federal Fiscal Year (FFY) 2005, the Department of Justice combined the Byrne Formula and Local Law Enforcement Block Grant (LLEBG) programs into the JAG program. The City of Oklahoma City received nine LLEBGs for a total of approximately \$9.6 million dollars. Projects completed include the pilot project for the Reduction of Accidents, Aggressive and Inconsiderate Drivers (RAAID) program, part-time salaries and overtime for Community Policing programs, computer upgrades, police vehicles, radar units and other equipment for law enforcement purposes. The City has received 13 JAG grants, including one funded by the American Recovery and Reinvestment Act of 2009, for a total of more than \$7.2 million dollars. The FFY 2015 JAG acceptance was approved by City Council on October 13, 2015 (IX. No. N.1.&2.). The FFY 2016 JAG award includes a disparate allocation provision for Oklahoma County. Del City and Midwest City are also parties in the joint application for funds.

The Chief of Police, the Oklahoma County Sheriff and a representative from each of the cities listed above have agreed to a joint application amount that was included in a memorandum of understanding signed by all parties. The cities agreed to share 17.5% of their original allocations with Oklahoma County. In addition, the allocations for Oklahoma County and the cities will be increased by 2.5% in lieu of a monthly interest distribution. The County and the cities agreed that the fiscal agent for the grant will be The City of Oklahoma City. The Oklahoma City Police Department plans to use JAG funds to continue funding of the Victim Services Coordinator position and the Sex Offender Registry Part-time Program, and for the purchase of Body-Worn Cameras.

Oklahoma County, Del City and Midwest City all proposed to utilize JAG funds for the purchase of equipment for law enforcement purposes. The grant terms and special conditions and the FFY 2016 subrecipient agreement are attached for review and approval.

RESOLUTION AUTHORIZING ACCEPTANCE OF THE JOINT AWARD FOR THE 2016 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT; RATIFYING SUBMITTAL OF THE INTERNET BASED APPLICATION BY THE CHIEF OF POLICE AND THE POLICE DEPARTMENT BUSINESS MANAGER; APPROVING THE FEDERAL FISCAL YEAR 2016 CITY OF OKLAHOMA CITY JAG SUBRECIPIENT ACCEPTANCE AND FISCAL AGENT AGREEMENT; AUTHORIZING THE MAYOR TO SIGN ANY NECESSARY DOCUMENTS; AUTHORIZING THE CITY TREASURER TO RECEIVE AND DEPOSIT THE FUNDS IN THE GRANTS MANAGEMENT FUND; AUTHORIZING THE POLICE BUSINESS MANAGER OR MANAGEMENT SPECIALIST TO SUBMIT THE INTERNET ACCEPTANCE, REQUESTS FOR FUNDS, TO PROVIDE REPORTS AS REQUIRED, AND TO ADMINISTER THE GRANT AND SUBRECIPIENT AGREEMENTS.

WHEREAS, the grant terms and special conditions and the FFY 2016 subrecipient agreement are attached for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Oklahoma City that the City is authorized to accept the joint award for the 2016 Edward Byrne Memorial Justice Assistance Grant (JAG) of \$495,718 from the Department of Justice, Bureau of Justice Programs.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the Mayor is authorized to execute the grant agreement, and the City Treasurer is authorized to receive and deposit these funds into Grants Management Fund 019.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the Police Business Manager or Management Specialist are authorized to submit the internet acceptance, to submit requests for funds, and to provide reports as required, and to administer the grant and Subrecipient Agreements provided that signed originals are placed on file with the City Clerk.

Dear Mayor Cornett:

Congratulations on your recent award. In establishing financial assistance programs, Congress linked the receipt of federal funding to compliance with federal civil rights laws. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) is responsible for ensuring that recipients of financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) comply with the applicable federal civil rights laws. We at the OCR are available to help you and your organization meet the civil rights requirements that come with DOJ funding.

Ensuring Access to Federally Assisted Programs

Federal laws that apply to recipients of financial assistance from the DOJ prohibit discrimination on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in employment but also in the delivery of services or benefits. A federal law also prohibits recipients from discriminating on the basis of age in the delivery of services or benefits.

In March of 2013, President Obama signed the Violence Against Women Reauthorization Act of 2013. The statute amends the Violence Against Women Act of 1994 (VAWA) by including a nondiscrimination grant condition that prohibits discrimination based on actual or perceived race, color, national origin, religion, sex, disability, sexual orientation, or gender identity. The new nondiscrimination grant condition applies to certain programs funded after October 1, 2013. The OCR and the OVW have developed answers to some frequently asked questions about this provision to assist recipients of VAWA funds to understand their obligations. The Frequently Asked Questions are available at <http://ojp.gov/about/ocr/vawafaqs.htm>.

Enforcing Civil Rights Laws

All recipients of federal financial assistance, regardless of the particular funding source, the amount of the grant award, or the number of employees in the workforce, are subject to prohibitions against unlawful discrimination. Accordingly, the OCR investigates recipients that are the subject of discrimination complaints from both individuals and groups. In addition, based on regulatory criteria, the OCR selects a number of recipients each year for compliance reviews, audits that require recipients to submit data showing that they are providing services equitably to all segments of their service population and that their employment practices meet equal opportunity standards.

Providing Services to Limited English Proficiency (LEP) Individuals

In accordance with DOJ guidance pertaining to Title VI of the Civil Rights Act of 1964, 42 U.S.C. § 2000d, recipients of federal financial assistance must take reasonable steps to provide meaningful access to their programs and activities for persons with limited English proficiency (LEP). See U.S. Department of Justice, Guidance to Federal Financial Assistance Recipients Regarding Title VI Prohibition Against National Origin Discrimination Affecting Limited English Proficient Persons, 67 Fed. Reg. 41,455 (2002). For more information on the civil rights responsibilities that recipients have in providing language services to LEP individuals, please see the website <http://www.lep.gov>.

Ensuring Equal Treatment for Faith-Based Organizations

The DOJ regulation, Equal Treatment for Faith-Based Organizations, 28 C.F.R. pt. 38, requires State Administering Agencies (SAAs) to treat faith-based organizations the same as any other applicant or recipient. The regulation prohibits SAAs from making awards or grant administration decisions on the basis of an organization's religious character or affiliation, religious name, or the religious composition of its board of directors.

The regulation also prohibits faith-based organizations from using financial assistance from the DOJ to fund inherently (or explicitly) religious activities. While faith-based organizations can engage in non-funded inherently religious activities, they must hold them separately from the program funded by the DOJ, and recipients cannot compel beneficiaries to participate in them. The Equal Treatment Regulation also makes clear that organizations participating in programs funded by the DOJ are not permitted to discriminate in the provision of services on the basis of a beneficiary's religion. For more information on the regulation, please see the OCR's website at http://www.ojp.usdoj.gov/about/ocr/equal_fbo.htm.

SAAs and faith-based organizations should also note that the Omnibus Crime Control and Safe Streets Act (Safe Streets Act) of 1968, as amended, 42 U.S.C. § 3789d(c); the Victims of Crime Act of 1984, as amended, 42 U.S.C. § 10604(e); the Juvenile Justice and Delinquency Prevention Act of 1974, as amended, 42 U.S.C. § 5672(b); and VAWA, Pub. L. No. 113-4, sec. 3(b)(4), 127 Stat. 54, 61-62 (to be codified at 42 U.S.C. § 13925(b)(13)) contain prohibitions against discrimination on the basis of religion in employment. Despite these nondiscrimination provisions, the DOJ has concluded that it may construe the Religious Freedom Restoration Act (RFRA) on a case-by-case basis to permit some faith-based organizations to receive DOJ funds while taking into account religion when hiring staff, even if the statute that authorizes the funding program generally forbids recipients from considering religion in employment decisions. Please consult with the OCR if you have any questions about the regulation or the application of RFRA to the statutes that prohibit discrimination in employment.

Using Arrest and Conviction Records in Making Employment Decisions

The OCR issued an advisory document for recipients on the proper use of arrest and conviction records in making hiring decisions. See Advisory for Recipients of Financial Assistance from the U.S. Department of Justice on the U.S. Equal Employment Opportunity Commission's Enforcement Guidance: Consideration of Arrest and Conviction Records in Employment Decisions Under Title VII of the Civil Rights Act of 1964 (June 2013), available at http://www.ojp.usdoj.gov/about/ocr/pdfs/UseofConviction_Advisory.pdf. Recipients should be mindful that the misuse of arrest or conviction records to screen either applicants for employment or employees for retention or promotion may have a disparate impact based on race or national origin, resulting in unlawful employment discrimination. In light of the Advisory, recipients should consult local counsel in reviewing their employment practices. If warranted, recipients should also incorporate an analysis of the use of arrest and conviction records in their Equal Employment Opportunity Plans (EEOs) (see below).

Complying with the Safe Streets Act

An organization that is a recipient of financial assistance subject to the nondiscrimination provisions of the Safe Streets Act, must meet two obligations: (1) complying with the federal regulation pertaining to the development of an EEO (see 28 C.F.R. pt. 42, subpt. E) and (2) submitting to the OCR findings of discrimination (see 28 C.F.R. §§ 42.204(c), .205(c)(5)).

Meeting the EEOP Requirement

If your organization has less than fifty employees or receives an award of less than \$25,000 or is a nonprofit organization, a medical institution, an educational institution, or an Indian tribe, then it is exempt from the EEOP requirement. To claim the exemption, your organization must complete and submit Section A of the Certification Form, which is available online at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

If your organization is a government agency or private business and receives an award of \$25,000 or more, but less than \$500,000, and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form), but it does not have to submit the report to the OCR for review. Instead, your organization has to maintain the Utilization Report on file and make it available for review on request. In addition, your organization has to complete Section B of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

If your organization is a government agency or private business and has received an award for \$500,000 or more and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form) and submit it to the OCR for review within sixty days from the date of this letter. For assistance in developing a Utilization Report, please consult the OCR's website at <http://www.ojp.usdoj.gov/about/ocr/eeop.htm>. In addition, your organization has to complete Section C of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

To comply with the EEOP requirements, you may request technical assistance from an EEOP specialist at the OCR by telephone at (202) 307-0690, by TTY at (202) 307-2027, or by e-mail at EEOSubmission@usdoj.gov.

Meeting the Requirement to Submit Findings of Discrimination


If in the three years prior to the date of the grant award, your organization has received an adverse finding of discrimination based on race, color, national origin, religion, or sex, after a due-process hearing, from a state or federal court or from a state or federal administrative agency, your organization must send a copy of the finding to the OCR.

Ensuring the Compliance of Subrecipients

SAs must have standard assurances to notify subrecipients of their civil rights obligations, written procedures to address discrimination complaints filed against subrecipients, methods to monitor subrecipients' compliance with civil rights requirements, and a program to train subrecipients on applicable civil rights laws. In addition, SAs must submit to the OCR every three years written Methods of Administration (MOA) that summarize the policies and procedures that they have implemented to ensure the civil rights compliance of subrecipients. SPECIAL CONDITIONS

1. Applicability of Part 200 Uniform Requirements

The Uniform Administrative Requirements, Cost Principles, and Audit Requirements in 2 C.F.R. Part 200, as adopted and supplemented by the Department of Justice (DOJ) in 2 C.F.R. Part 2800 (together, the "Part 200 Uniform Requirements") apply to this 2016 award from the Office of Justice Programs (OJP).

The Part 200 Uniform Requirements were first adopted by DOJ on December 26, 2014. If this 2016 award supplements funds previously awarded by OJP under the same award number (e.g., funds awarded in 2014 or earlier years), the Part 200 Uniform Requirements apply with respect to all funds under that award number (regardless of the award date, and regardless of whether derived from the initial award or a supplemental award) that are obligated on or after the acceptance date of this 2016 award.

3. Required training for Point of Contact and all Financial Points of Contact

Both the Point of Contact (POC) and all Financial Points of Contact (FPOCs) for this award must have successfully completed an "OJP financial management and grant administration training" by 120 days after the date of the recipient's acceptance of the award. Successful completion of such a training on or after January 1, 2015, will satisfy this condition.

In the event that either the POC or an FPOC for this award changes during the period of performance, the new POC or FPOC must have successfully completed an "OJP financial management and grant administration training" by 120 calendar days after -- (1) the date of OJP's approval of the "Change Grantee Contact" GAN (in the case of a new POC), or (2) the date the POC enters information on the new FPOC in GMS (in the case of a new FPOC). Successful completion of such a training on or after January 1, 2015, will satisfy this condition.

The recipient should anticipate that OJP will immediately withhold ("freeze") award funds if the recipient fails to comply with this condition. The recipient's failure to comply also may lead OJP to impose additional appropriate conditions on this award.

4. Requirements related to "de minimis" indirect cost rate

A recipient that is eligible under the Part 200 Uniform Requirements and other applicable law to use the "de minimis" indirect cost rate described in 2 C.F.R. 200.414(f), and that elects to use the "de minimis" indirect cost rate, must advise OJP in writing of both its eligibility and its election, and must comply with all associated requirements in the Part 200 Uniform Requirements. The "de minimis" rate may be applied only to modified total direct costs (MTDC) as defined by the Part 200 Uniform Requirements.

5. Requirement to report potentially duplicative funding

If the recipient currently has other active awards of federal funds, or if the recipient receives any other award of federal funds during the period of performance for this award, the recipient promptly must determine whether funds from any of those other federal awards have been, are being, or are to be used (in whole or in part) for one or more of the identical cost items for which funds are provided under this award. If so, the recipient must promptly notify the DOJ awarding agency (OJP or OVW, as appropriate) in writing of the potential duplication, and, if so requested by DOJ awarding agency, must seek a budget-modification or change-of-project-scope grant adjustment notice (GAN) to eliminate any inappropriate duplication of funding.

6. Requirements related to System for Award Management and Unique Entity Identifiers

The recipient must comply with applicable requirements regarding the System for Award Management (SAM), currently accessible at <http://www.sam.gov>. This includes applicable requirements regarding registration with SAM, as well as maintaining the currency of information in SAM.

The recipient also must comply with applicable restrictions on subawards ("subgrants") to first-tier subrecipients (first-tier "subgrantees"), including restrictions on subawards to entities that do not acquire and provide (to the recipient) the unique entity identifier required for SAM registration.

35. The grantee agrees to assist BJA in complying with the National Environmental Policy Act (NEPA), the National Historic Preservation Act, and other related federal environmental impact analyses requirements in the use of these grant funds, either directly by the grantee or by a subgrantee. Accordingly, the grantee agrees to first determine if any of the following activities will be funded by the grant, prior to obligating funds for any of these purposes. If it is determined that any of the following activities will be funded by the grant, the grantee agrees to contact BJA.

The grantee understands that this special condition applies to its following new activities whether or not they are being specifically funded with these grant funds. Ballistic-resistant and stab-resistant body armor purchased with JAG funds may be purchased at any threat level, make or model, from any distributor or manufacturer, as long as the vests have been tested and found to comply with applicable National Institute of Justice ballistic or stab standards and are listed on the NIJ Compliant Body Armor Model List (<http://nij.gov>). In addition, ballistic-resistant and stab-resistant body armor purchased must be American-made. 39. The recipient agrees to submit a signed certification that all law enforcement agencies receiving vests purchased with JAG funds have a written "mandatory wear" policy in effect. Fiscal agents and state agencies must keep signed certifications on file for any subrecipients planning to utilize JAG funds for ballistic-resistant and stab-resistant body armor purchases. This policy must be in place for at least all uniformed officers before any JAG funding can be used by the agency for body armor. There are no requirements regarding the nature of the policy other than it be a mandatory wear policy for all uniformed officers while on duty.

Subject: Incorporates NEPA Compliance in Further Developmental Stages for City of Oklahoma City

The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and local governments to support a broad range of activities to prevent and control crime and to improve the criminal justice system, some of which could have environmental impacts. All recipients of JAG funding must assist BJA in complying with NEPA and other related federal environmental impact analyses requirements in the use of grant funds, whether the funds are used directly by the grantee or by a subgrantee or third party. Accordingly, prior to obligating funds for any of the specified activities, the grantee must first determine if any of the specified activities will be funded by the grant.

The specified activities requiring environmental analysis are:

- a. New construction;

Complying with NEPA may require the preparation of an Environmental Assessment and/or an Environmental Impact Statement, as directed by BJA. Further, for programs relating to methamphetamine laboratory operations, the preparation of a detailed Mitigation Plan will be required. Equipment for Law Enforcement Purposes, Victim Services and Sex Offender Registry Project

Victim Services Coordinator

Victims of crime in Oklahoma City do not have access or knowledge about the many services that are available to them. The goal of the Victims Services Coordinator is to provide immediate and comprehensive law enforcement based advocacy and support services to victims of crime. A monthly performance data report details the number of victims served, type of crime involved, and type of service involved.

Sex Offender Registry Part-Time

There are currently 1,236 offenders required to continually register with the Oklahoma City Police Department. The goal is for four part-time civilians to complete the registrations, which allows sworn personnel to conduct investigations regarding failure to register and file charges. Monthly performance data activity on the part-time employees is documented.

Body-Worn Cameras

The Oklahoma City Police Department has recognized the value body-worn cameras (BWCs) can bring to the health of our community and the function of our department. The addition of 100 cameras to our officers will assist in the de-escalation of conflicts, reduction in complaints and uses of force, documentation of evidence, improvement in officer safety, increase citizen trust, and aid in prosecutions. Monthly performance data activity on the program is collected from various components of the Police Department.

Oklahoma County Sheriff's Office (OCSO) Microwave Equipment, Mobile Data Vehicle Modems and Data Server/Storage Replacement

OCSO has microwave equipment, mobile cellular modems and data servers that are aging and in need of replacement. The goal is to replace the outdated equipment which will provide for a faster, reliable and stable infrastructure for law enforcement data and communications. Another component of this project is the addition of new microwave equipment which will provide an increase in reliability of the system. Performance data captured will include monthly use and monitoring reports.

Del City Audio/Video Recording System Replacement

The Del City Police Department needs to replace its camera and recording system that is no longer in working order. The project will provide for better audio and video monitoring for areas such as; jail and booking room, interview rooms, and public areas throughout the building. It will also provide increased safety and security for Officers and Citizens. Performance data captured will include monthly use and monitoring reports.

Midwest City Police Department Tasers

Several Tasers within the department have reached the end of their useful life and replacements have become necessary. WHEREAS, the Department of Justice has determined that successful applicants for awards under the Office of Justice Programs must comply with several application requirements, including the execution of a memorandum of understanding among the authorized officials of each jurisdiction to select a fiscal agent and to submit a joint application for sharing of specified grant amounts; and

WHEREAS, authorized by its governing body, each of the undersigned chief law enforcement officials agrees that this memorandum of understanding is in the best interests of all parties, that the undertaking will benefit the public, and that the division of grant funds fairly allocates the available resources; and

WHEREAS, the Cities and the County believe it to be in their best interests to reallocate the JAG funds as required by the granting entity, the United States Department of Justice.

NOW THEREFORE, the County and Cities agree as follows:

Section 1.

The parties agree that the Fiscal Agent for the grant will be The City of Oklahoma City. No funds will be remitted to a party hereto unless and until the Fiscal Agent is satisfied that all required documentation has been properly completed by that party, that all necessary governing-body approvals have been docketed and adopted, that all public notices have been given, that acceptable documentation has been preserved and necessary documentation has been submitted, and that all local, state and federal accounting and program requirements have been satisfied. Reimbursement of expenditures by the Fiscal Agent shall not negate each party's obligation under federal law to repay the federal government for amounts that are disallowed by the federal government. Each party hereto agrees to submit to its governing body for approval a separate Subaward and Fiscal Agent Agreement to be approved by the governing body and signed by the mayor or city manager of a City or by the chair of the Board of County Commissioners.

Section 2.

The City of Oklahoma City has agreed to not charge the Cities or the County the ten percent (10%) of the grant amount allowed for administration. The BJA FY 16 JAG funds will be allocated as in the original BJA FY 16 JAG allocation less the 17.5% disparate share to Oklahoma County. In addition, the allocations for Oklahoma County, Del City, and Midwest City, will be increased by two and one half percent (2.5%) in lieu of a monthly interest distribution. Based on this formula the reallocation of the BJA FY 16 JAG award is as follows:

- Oklahoma County will receive \$ 88,919 of JAG funds;
- Del City will receive \$ 11,107 of JAG funds;
- Midwest City will receive \$ 21,275 of JAG funds; and
- The City of Oklahoma City will receive \$ 374,417 of the federal grant award and all interest earned by the BJA FY 16 JAG award.

Under the JAG Program, the cities of Del City, Midwest City, and Oklahoma County will operate on a reimbursement basis. Interest will be earned and retained by The City of Oklahoma City. Interest proceeds will only be expended by The City of Oklahoma City for the purposes as allowed by the federal award. Interest income is considered federal funding in the JAG Program.

Section 3.

Oklahoma County agrees to spend their allocation of JAG funds for Equipment for Law Enforcement Purposes on or before September 30, 2018. The cities of Del City and Midwest City agree to spend their allocations of JAG funds for Equipment for Law Enforcement Purposes on or before September 30, 2017. The City of Oklahoma City will expend their allocation of JAG funds for administration, equipment, overtime, or salaries and benefits for Law Enforcement Purposes.

Section 4.

The parties further agree that The City of Oklahoma City, Del City, Midwest City, and Oklahoma County will be responsible for their own compliance in every federal, state and local requirement of the grant award and shall be liable for their own failure to comply including any repayment of disallowed costs. This compliance will include, but not be

limited to, the timely submission of properly executed grant applications, acceptance and certification documents, audits, reports, claims and supporting documentation that may be requested by the fiscal agent or the granting entity. No funds will be remitted to a subgrantee unless and until all required documentation has been completed and timely received to the satisfaction of the Fiscal Agent and in compliance with all applicable laws and grant requirements. All parties acknowledge and understand that these grant funds are subject to strict reporting and record-keeping requirements and failure to timely provide such reporting as required by the Fiscal Agent pursuant to federal law may result in a loss of reimbursement eligibility.

Section 5.

Each party to this memorandum of understanding will be responsible for its own acts under this memorandum of understanding and shall not be liable for any civil liability that may arise from the acts of any other party.

Section 6.

The parties to this memorandum of understanding do not intend for any third party to obtain a right or benefit by virtue of this memorandum of understanding.



AVAILABILITY OF FUNDS

The City of Oklahoma City (also referred to herein as “Fiscal Agent” or “Prime Recipient”) and the cities of Del City, and Midwest City, and Oklahoma County (hereinafter “Subrecipients”) have signed a Memorandum of Understanding, a copy of which is incorporated herein, and therein agreed that The City of Oklahoma City, as Prime Recipient, shall also be the Fiscal Agent for the federal Justice Assistance Grant (JAG) Program.

Each Subrecipient shall submit to Fiscal Agent for approval the expenditure of funds from the allocations designated for each of the Subrecipients. Representatives of the Fiscal Agent and of the federal government, including the Department of Justice and the Comptroller General, have the right to examine records and documents related to the grant or expenditures of federal funds. No funds will be remitted to a party hereto unless and until the Fiscal Agent is satisfied that all required documentation has been properly completed by that party, that all necessary governing-body approvals have been docketed and adopted, that all public notices have been given, that acceptable documentation has been preserved and necessary documentation has been submitted, and that all local, state and federal accounting and program requirements have been satisfied. Reimbursement of expenditures by the Fiscal Agent shall not negate each Subrecipient’s individual obligation under federal law to repay the federal government for amounts that are disallowed by the federal government.

PURPOSE

The purpose of this grant is to prevent and control crime. Department of Justice funding for JAG Program grants is intended to assist local law enforcement, including support for hiring, to combat violence against women, to fight internet crimes against children, to improve the functioning of the criminal justice system, to assist victims of crime, and to support youth mentoring.

PROHIBITION ON USE OF FUNDS

Units of local government shall not expend funds provided under the JAG Grant to purchase, lease, rent or acquire any of the following:

- 1) tanks or armored vehicles;
- 2) fixed wing aircraft;
- 3) limousines;
- 4) real estate;
- 5) yachts;
- 6) consultants; or
- 7) unmanned aircraft, unmanned aircraft systems, or aerial vehicles.

MATCH REQUIREMENT

There is no cash or in-kind match requirement for this funding.

REIMBURSEMENT OF FUNDS

Under the JAG Program, subrecipients will operate on a reimbursement basis. **In order to**

receive federal JAG funds, subrecipients must properly procure and pay for all approved equipment prior to receiving reimbursement from grant funds. Subrecipients must submit all required proof-of-purchasing documents prior to receiving payment. Upon receipt **and approval** of the proof-of-purchasing documents, reimbursement will be forwarded to the subrecipient in approximately three weeks. Expenses should be submitted to the Oklahoma City Police Department, along with any required reports, no later than 30 days after the date of the expenditure of funds. This award is subject to all administrative and financial requirements, including the timely submission of all financial and programmatic reports, resolution of all interim audit findings, and the maintenance of a minimum level of cash-on-hand. Should a subrecipient not adhere to these requirements, the subrecipient will be in violation of the terms of this agreement and the award will be subject to termination for cause or other administrative action as appropriate.

AWARD PERIOD/AMOUNT

The award period for this grant shall begin on October 1, 2015, and not extend beyond September 30, 2019, for the Prime Recipient. The award amounts listed in Attachment A are “not to exceed” amounts. Any funds not claimed by the Subrecipients by December 31, 2018, may be reallocated to the Prime Recipient.

NON-SUPPLANTING OF FUNDS

The definition of supplanting means to deliberately reduce a local budget by using federal funds to replace local funds designated for the same purpose. An example of supplanting is when a local entity budgets \$5,000 for equipment and seeks federal grant funds to purchase additional equipment. Rather than spending the \$5,000 as designated by the appropriation, the agency uses \$5,000 of federal funds awarded for the same purpose. The agency replaced the local funds with federal funds thereby reducing the total amount available for the identified purpose. A federal award must enhance or supplement an existing budget and not decrease it because of the use of federal funds.

COMMINGLING OF FUNDS

A physical segregation of cash deposits that are provided to a subrecipient is not required. However, the accounting systems of all subrecipients must ensure that agency funds are not commingled with funds from other federal agencies. Each award must be accounted for separately. Subrecipients are prohibited from commingling funds on either a program-by-program basis or a project-by-project basis. Funds specifically budgeted and/or received for one project shall not be used to support another. Where a subrecipient’s accounting system cannot comply with this requirement, the subrecipient shall establish a system to provide adequate fund accountability for each grant which it was awarded.

ACCOUNTABILITY AND REPORTING REQUIREMENTS

The parties further agree that The City of Oklahoma City and the subrecipients will each be responsible for its own compliance with every federal, state and local requirement of the grant award and shall be severally liable for its own failure to comply, including any repayment of disallowed costs. This compliance will include, but not be limited to, the timely submission of

properly executed grant applications, acceptance and certification documents, audits, reports, claims and supporting documentation that may be requested by the Fiscal Agent or the Justice Department. No funds will be remitted to a subrecipient unless and until all required documentation has been completed and timely received to the satisfaction of the Fiscal Agent and in compliance with all applicable laws and grant requirements. All parties acknowledge and understand that these grant funds are subject to strict reporting and record-keeping requirements, and failure to timely provide such reporting as required by the Fiscal Agent may result in a loss of reimbursement eligibility pursuant to federal law. Federal grants are governed by the provisions of the Office of Management and Budget circulars applicable to financial assistance and Office of Justice Program's Financial Guide (which is available from the Office of Justice Program web site at www.ojp.usdoj.gov/oc). The Financial Guide includes information on allowable costs, methods of payment, audit requirements, accounting systems, and financial records. Audits of local units of government must comply with the organizational audit requirements of OMB circular A-133, which states that recipients who expend \$500,000 or more of federal funds during their fiscal year are required to submit a single organization wide financial and compliance audit report to the Federal Audit Clearinghouse within nine (9) months after the close of each fiscal year during the term of the award.

Section 1.

The parties agree that the Fiscal Agent for the grant will be The City of Oklahoma City. No funds will be remitted to a party hereto unless and until the Fiscal Agent is satisfied that all required documentation has been properly completed by that party, that all necessary governing-body approvals have been docketed and adopted, that all public notices have been given, that acceptable documentation has been preserved and necessary documentation has been submitted, and that all local, state and federal accounting and program requirements have been satisfied. Reimbursement of expenditures by the Fiscal Agent shall not negate each party's obligation under federal law to repay the federal government for amounts that are disallowed by the federal government. Each party hereto agrees to submit to its governing body for approval a separate Subaward and Fiscal Agent Agreement to be approved by the governing body and signed by the mayor or city manager of a City or by the chair of the Board of County Commissioners.

Section 2.

The City of Oklahoma City has agreed to not charge the Cities or the County the ten percent (10%) of the grant amount allowed for administration. The BJA FY 16 JAG funds will be allocated as in the original BJA FY 16 JAG allocation less the 17.5% disparate share to Oklahoma County. In addition, the allocations for Oklahoma County, Del City, and Midwest City, will be increased by two and one half percent (2.5%) in lieu of a monthly interest distribution. Based on this formula the reallocation of the BJA FY 16 JAG award is as follows:

- Oklahoma County will receive \$ 88,919 of JAG funds;
- Del City will receive \$ 11,107 of JAG funds;
- Midwest City will receive \$ 21,275 of JAG funds; and
- The City of Oklahoma City will receive \$ 374,417 of the federal grant award and all interest earned by the BJA FY 16 JAG award.

Under the JAG Program, the cities of Del City, Midwest City, and Oklahoma County will operate on a reimbursement basis. Interest will be earned and retained by The City of Oklahoma City. Interest proceeds will only be expended by The City of Oklahoma City for the purposes as allowed by the federal award. Interest income is considered federal funding in the JAG Program.

Section 3.

Oklahoma County agrees to spend their allocation of JAG funds for Equipment for Law Enforcement Purposes on or before September 30, 2018. The cities of Del City and Midwest City agree to spend their allocations of JAG funds for Equipment for Law Enforcement Purposes on or before September 30, 2017. The City of Oklahoma City will expend their allocation of JAG funds for administration, equipment, overtime, or salaries and benefits for Law Enforcement Purposes.

Section 4.

The parties further agree that The City of Oklahoma City, Del City, Midwest City, and Oklahoma County will be responsible for their own compliance in every federal, state and local requirement of the grant award and shall be liable for their own failure to comply including any repayment of disallowed costs. This compliance will include, but not be





Congratulations on your recent award. In establishing financial assistance programs, Congress linked the receipt of federal funding to compliance with federal civil rights laws. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) is responsible for ensuring that recipients of financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) comply with the applicable federal civil rights laws. We at the OCR are available to help you and your organization meet the civil rights requirements that come with DOJ funding.

Ensuring Access to Federally Assisted Programs

Federal laws that apply to recipients of financial assistance from the DOJ prohibit discrimination on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in employment but also in the delivery of services or benefits. A federal law also prohibits recipients from discriminating on the basis of age in the delivery of services or benefits.

In March of 2013, President Obama signed the Violence Against Women Reauthorization Act of 2013. The statute amends the Violence Against Women Act of 1994 (VAWA) by including a nondiscrimination grant condition that prohibits discrimination based on actual or perceived race, color, national origin, religion, sex, disability, sexual orientation, or gender identity. The new nondiscrimination grant condition applies to certain programs funded after October 1, 2013. The OCR and the OVW have developed answers to some frequently asked questions about this provision to assist recipients of VAWA funds to understand their obligations. Enforcing Civil Rights Laws

All recipients of federal financial assistance, regardless of the particular funding source, the amount of the grant award, or the number of employees in the workforce, are subject to prohibitions against unlawful discrimination. Accordingly, the OCR investigates recipients that are the subject of discrimination complaints from both individuals and groups. Despite these nondiscrimination provisions, the DOJ has concluded that it may construe the Religious Freedom Restoration Act (RFRA) on a case-by-case basis to permit some faith-based organizations to receive DOJ funds while taking into account religion when hiring staff, even if the statute that authorizes the funding program generally forbids recipients from considering religion in employment decisions. Please consult with the OCR if you have any questions about the regulation or the application of RFRA to the statutes that prohibit discrimination in employment.

Using Arrest and Conviction Records in Making Employment Decisions

The OCR issued an advisory document for recipients on the proper use of arrest and conviction records in making hiring decisions. See Advisory for Recipients of Financial Assistance from the U.S. Department of Justice on the U.S. Equal Employment Opportunity Commission's Enforcement Guidance: Consideration of Arrest and Conviction Records in Employment Decisions Under Title VII of the Civil Rights Act of 1964 (June 2013), available at http://www.ojp.usdoj.gov/about/ocr/pdfs/UseofConviction_Advisory.pdf. Recipients should be mindful that the misuse of arrest or conviction records to screen either applicants for employment or employees for retention or promotion may have a disparate impact based on race or national origin, resulting in unlawful employment discrimination. In light of the Advisory, recipients should consult local counsel in reviewing their employment practices. If warranted, recipients should also incorporate an analysis of the use of arrest and conviction records in their Equal Employment Opportunity Plans (EEOs) (see below).

Complying with the Safe Streets Act

An organization that is a recipient of financial assistance subject to the nondiscrimination provisions of the Safe Streets Act, must meet two obligations: (1) complying with the federal regulation pertaining to the development of an EEO (see 28 C.F.R. pt. 42, subpt. E) and (2) submitting to the OCR findings of discrimination (see 28 C.F.R. §§ 42.204(c), .205(c)(5)).

Meeting the EEOP Requirement

If your organization has less than fifty employees or receives an award of less than \$25,000 or is a nonprofit organization, a medical institution, an educational institution, or an Indian tribe, then it is exempt from the EEOP requirement. If your organization is a government agency or private business and receives an award of \$25,000 or more, but less than \$500,000, and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form), but it does not have to submit the report to the OCR for review. Instead, your organization has to maintain the Utilization Report on file and make it available for review on request. In addition, your organization has to complete Section B of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

If your organization is a government agency or private business and has received an award for \$500,000 or more and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form) and submit it to the OCR for review within sixty days from the date of this letter. For assistance in developing a Utilization Report, please consult the OCR's website at <http://www.ojp.usdoj.gov/about/ocr/eeop.htm>. In addition, your organization has to complete Section C of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

To comply with the EEOP requirements, you may request technical assistance from an EEOP specialist at the OCR by telephone at (202) 307-0690, by TTY at (202) 307-2027, or by e-mail at EEOSubmission@usdoj.gov.

Meeting the Requirement to Submit Findings of Discrimination


If in the three years prior to the date of the grant award, your organization has received an adverse finding of discrimination based on race, color, national origin, religion, or sex, after a due-process hearing, from a state or federal court or from a state or federal administrative agency, your organization must send a copy of the finding to the OCR.

Ensuring the Compliance of Subrecipients

SAs must have standard assurances to notify subrecipients of their civil rights obligations, written procedures to address discrimination complaints filed against subrecipients, methods to monitor subrecipients' compliance with civil rights requirements, and a program to train subrecipients on applicable civil rights laws. In addition, SAs must submit to the OCR every three years written Methods of Administration (MOA) that summarize the policies and procedures that they have implemented to ensure the civil rights compliance of subrecipients.
