Public Art Commission Agreement with Nick Bayer, to provide public art for MAPS 3 Senior Health and Wellness Center No. 1, 11501 North Rockwell Avenue, not to exceed \$19,000. Ward 8.

11501 North Rockwell Avenue. Ward 8. Location

Purpose To commission a public art mural for MAPS 3 Senior Health & Wellness

Center No.1 under the 1% for Art ordinance. Anticipated completion is

first quarter of 2017.

On September 15, 2009 (Item No. IX. A.) City Council adopted Ordinance 23,935, establishing a requirement that 1% of budgeted expenditures for construction of new buildings, major renovation of

existing buildings, and significant park development, located on City land

or right-of-way, be set aside for public art.

On September 29, 2015 (Item No VII.R.), City Council authorized the advertisement of a Call to Artists for a Pre-Qualified Artist Pool for public art projects under \$25,000 and the Oklahoma City Arts Commission evaluated the artist submissions and approved the 2016-17 Pre-Qualified Artist Pool, for use for public art projects with budgets

under \$25,000, on February 15, 2016 (Item No. IV).

On September 15th, 2016, a meeting was held with the Architect and Operator to discuss 1% for Art opportunities and to develop project scope for a mural and a budget under \$25,000 and Artist Nick Bayer was

selected from the Pre-Qualified Artist Pool.

Nick Bayer participated in a mandatory site tour on October 4th, 2016, and developed three site specific conceptual design reports which he presented to the Selection Committee on November 30, 2016. Selection Committee evaluated the artist's conceptual design reports and based on the results of the committee's evaluation, it was determined that one of the conceptual design report entitled, "Out For a Swim" best met the criteria for the project.

Background

The Arts Commission reviewed the Selection Committee's recommendation at a regularly scheduled meeting on December 19th, 2016 (Item No. III.) and concurred with the Selection Committee's recommendation.

City Council authorized staff to negotiate an agreement with Nick Bayer, for a mural for MAPS 3 Senior Health and Wellness Center No. 1 on January 3, 2017 (Item No. VII. H.).
