Resolution approving Amendment No. 4, Project M3-S005, MAPS 3 Modern Streetcar Vehicles, increase of \$4,534,645.

Background	As a part of the MAPS 3 Program, The City of Oklahoma City will construct/purchase a new downtown modern streetcar system.
	A contract with Brookville Equipment Corporation was approved in March 2016 to purchase five vehicles. The contract included a provision to purchase an additional car within 90 days of approval of the contract. Due to the realigned streetcar route, which will provide streetcar service to the MAPS 3 Park and Convention Center, purchase of an additional streetcar was approved in May 2016.
	The mainline bids came in under budget; therefore, excess construction funds are available. The MAPS 3 Transit/Modern Streetcar subcommittee recommends purchasing a seventh vehicle in amount of \$4,534,645 to increase the spare vehicle percentage from 20% to 40%. The contract allows for another vehicle to be purchased within 13 months of the original contract at a specified bid price of \$4,534,645 and still meet the manufacturing schedule.
	The MAPS 3 Citizens Advisory Board recommended approval on February 23, 2017.
