Resolution ratifying and approving Addenda Nos. 1 and 2, Project M3-T002B, MAPS 3 Will Rogers Trail - Phase 2 Project 3, NW Grand Boulevard/NW 19th Street to South May Avenue/Oklahoma River; awarding contract to Shell Construction Co., Inc., \$2,548,525.39; and approving contract and bonds. Ward 6.

Location	Vicinity of NW Grand Boulevard/NW 19th Street to South May Avenue/Oklahoma River		
Background	As a part of the MAPS 3 Program, the City of Oklahoma City intends to develop several miles of trails, including a trail from Lake Hefner to the Oklahoma River. This section is the southern part of the Will Rogers Trail.		
	Addenda Nos. 1 and 2 were issued during bidding to clarify and modify the plans and specifications.		
	Bids were opened on April 4, 2017, and City staff considered all bids and recommend awarding the base bid plus Alternates 1, 2 and 3 to the low bidder, Shell Construction Co., Inc.		
	The MAPS 3 Citizens Advisory Board recommended approval on April 27, 2017.
