## The City of **OKLAHOMA CITY**

Ratifying and approving Addenda Nos. 1, 2, 3, 4, 5 and 6, Project M3-P006/WC-0920, MAPS 3 Upper Park; awarding joint contract with the Oklahoma City Water Utilities Trust to Downey Construction, LLC, generally bound by the Oklahoma City Boulevard, South Hudson Avenue, I-40, and South Robinson Avenue, \$57,639,832.15; and approving contract and bonds; and authorizing use of Oklahoma City Capital Improvement Sales Tax Contingency funds to fund the deficit of the project in an amount of \$5,755,406.15. Ward 6.

Background As a part of the MAPS 3 Program, The City of Oklahoma City intends

to construct a new downtown public park.

Bids were opened on May 9, 2017 with only one bid received. The MAPS 3 Parks Subcommittee and MAPS 3 Citizens Advisory Board reviewed the bid and alternates and recommend awarding the base bid plus Alternates 1, 2, 3, 4, 5, 6, 7 and 9 to Downey Contracting, LLC. Alternate 9 is to be funded by the Oklahoma City Water Utilities Trust.

Because funding multiple alternates exceeds the available funding, the MAPS 3 Parks Subcommittee voted to recommend utilizing Oklahoma City Capital Improvement Sales Tax contingency funds to fund the deficit of this project. The MAPS 3 Citizens Advisory Board voted to recommend utilizing Oklahoma City Capital Improvement Sales Tax contingency funds and/or excess collections to fund the deficit of this project. Staff concurs with the MAPS 3 Parks Subcommittee in utilizing contingency funds to fund the deficit of the project.

An existing 12-inch water main is located along SW 7th Street and was installed in the early 1900s. Additionally, this MAPS 3 project will

modify the existing site elevations putting additional fill on top of the main. Therefore, staff determined it to be in the best interest of the City and OCWUT to fund the replacement/relocation of the approximately 730 feet of 12-inch main as part of the MAPS 3 project.

The OCWUT and the City must receive the necessary easements, asbuilt drawings, and the maintenance bond for this project. After dedication to and acceptance by OCWUT and the City of this project, the water and sanitary sewer mains included in the project, excluding any private services lines, will become the property of the City. After acceptance of the project and expiration of the maintenance bond, the City, through the Utilities Department, will be responsible for future maintenance of the City-owned water and sanitary sewer mains.
